18	TO AMEND THE LAW CONCERNING THE
19	REDISTRICTING OF PRECINCTS; AND TO AMEND
20	THE LAW CONCERNING THE REPORTING OF
21	ELECTION RESULTS.

24	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25	
26	SECTION 1. Arkansas Code § 7-5-101(b)(4), concerning the establishment
27 28	and alteration of precinct boundaries, polling sites, and vote centers, is amended to read as follows:
28 29	(4)(A) An order to alter the boundaries of any precinct or
30	establish any new one shall not be effective until it has been filed with the
31	county clerk.
32	(B) The order shall contain:
33	(i) A written description of the boundaries of the
34	precinct;
35	(ii) A printed map of the boundaries of the precincts
36	altered or established; and

1	(iii) A digital map detailing the precinct boundaries
2	altered or established in a format prescribed by the Arkansas Geographic
3	Information Systems Office; and
4	(iv) The numerical codes designated for each
5	precinct.
6	(5) When redistricting the county board of election
7	commissioners shall:
8	(A) Designate precincts using a six digit numeric
9	<u>code:</u>
10	(i) The beginning three digits shall be the
11	Federal Information Processing Series numerical county location code used by
12	the United States Bureau of the Census;
13	(ii) The last three digits of the numeric code
14	shall be designated by the county board of election commissioners; and
15	(iii) A sequential numerical system beginning
16	with the precinct located in the northwest of the county;
17	(B) Ensure that precincts are numbered consecutively
18	with contiguous precincts having consecutive numbers;
19	(C) Develop precincts that are:
20	<u>(i) Contiguous;</u>
21	(ii) Compact;
22	(iii) Easily identifiable and understandable
23	by the voters; and
24	(iv) Easy to locate on a map of the county.
25	(6) As used in subdivision (b)(5)(C)(i), "contiguous"
26	means the boundaries of the precinct:
27	(i) Are touching;
28	(ii) Use major roads, railways, or other similar
29	infrastructure to delineate a portion of the outer boundary of the precinct,
30	if major roads, railways or other similar infrastructure is available; and
31	(iii) Use the edge of the body of water if possible
32	if the body of water is adjacent to or within the precinct, or the center of
33	the body of water if the body of water is not fully included in the precinct.

1 SECTION 2. Arkansas Code § 7-5-701(a)(3), concerning the declaration, 2 certification, delivery, and custody of election results and return, is amended to read as follows: 3 4 (3)(A) As results are received and tabulated on election night 5 for all state and federal elections, the county board of election 6 commissioners shall declare preliminary and unofficial results of the 7 election as soon as early voting, absentee, or individual precinct results 8 are tabulated on election night and immediately shall transmit the results by 9 precinct using the six digit numeric code precinct number to the Secretary of 10 State through the election night reporting interface provided by the Secretary of State. 11 12 (B) The county board of election commissioners may, by 13 agreement with the county clerk, transmit the results to the county clerk who 14 immediately shall transmit the results by precinct using the six digit 15 numeric code precinct number to the Secretary of State under subdivision 16 (a)(3)(A) of this section. 17 18 SECTION 3. Arkansas Code § 7-5-701(a)(3)(C)(ii), concerning the 19 declaration, certification, delivery, and custody of election results and 20 return, is amended to read as follows: 21 (ii) Immediately transmit the results by precinct 22 using the six digit numeric code precinct number to the Secretary of State 23 through the election night reporting interface provided by the Secretary of 24 State. 25 SECTION 4. Arkansas Code § 7-5-701(a)(3)(D) and (E), concerning the 26 27 declaration, certification, delivery, and custody of election results and 28 return, are amended to read as follows: 29 (D) The county board of election commissioners may, by agreement with the county clerk, transmit the results to the county clerk who 30 31 shall immediately transmit the results by precinct using the six digit 32 numeric code precinct number to the Secretary of State as described in subdivision (a)(3)(C) of this section. 33 34 (E) The Secretary of State may establish policies and 35 procedures to accomplish the objectives set forth under this section and the 36 format of the six digit numeric code precinct number.

2	SECTION 5. DO NOT CODIFY. Designation of precinct boundaries and six
3	digit numeric code precinct number.
4	Before the general election in 2028, each county board of election
5	commissioners shall establish all precinct boundaries under § 7-5-101 and
6	designate the precincts using the six digit numeric code precinct number.
