8	WHEREAS, on June 11, 2009, the Senate Subcommittee on Minority Health
9	held a legislative meeting in Helena-West Helena, Arkansas; and,
10	
11	WHEREAS, over three hundred (300) residents were present and were
12	provided an opportunity to inform the Subcommittee about the need for health
13	services, the perception of how existing services are being used, the gaps in
14	health services, and their health concerns; and
15	
16	WHEREAS, residents who addressed the Senate Subcommittee expressed a
17	reoccurring theme centered on the lack of progress made in cleaning up the
18	chemical spill at the Cedar Chemical Corporation and the perceived health
19	problems that the spill has caused and continues to cause the residents of
20	Helena-West Helena; and
21	
22	WHEREAS, the Arkansas Department of Environmental Quality researched
23	and determined that chemical spills from the site were contaminating the
24	groundwater; and
25	
26	WHEREAS, the safety of the community and its drinking water is vital to
27	the health and security of the residents; and
28	
29	WHEREAS, the cleanup of the site will be important for economic
30	development and attracting business to the area; and
31	
32	WHEREAS, the cleanup of the site is important in making Helena-West
33	Helena a thriving community to live in and to attract jobs,

35	NOW THEREFORE,
36	BE IT RESOLVED BY THE SENATE COMMITTEE ON PUBLIC HEALTH, WELFARE, AND LABOR
