20	representatives concerning the impact of the U.S. Environmental Protection
21	Agency's Clean Power Plan Proposed Rule on Arkansas's Electric Rates; and

23	WHEREAS, the U.S. Environmental Protection Agency announced its
24	proposed rule for performance standards for reducing carbon dioxide (CO2)
25	emissions from existing power plants under the Clean Air Act Section lll(d)
26	on June 2, 2014; and
27	
28	WHEREAS, the proposed rule requires each state to reduce its CO2
29	emissions rate from existing fossil fuel plants to meet state-specific
30	standards (in pounds per MWh) starting in 2020, with a final rate for 2030
31	and beyond; and

33	WHEREAS, the proposed rule will be devastating to the state's economy
34	and energy industry and is therefore contrary to the public policy of the
35	State of Arkansas,
