23	REQUESTING A STUDY FOR WAYS TO IMPROVE
24	THE STATE'S JUVENILE JUSTICE SYSTEM FOR

28	WHEREAS, there is cause to evaluate needed reforms of the state's
29	juvenile justice system to more effectively and efficiently serve youth
30	committed to the Division of Youth Services of the Department of Health and
31	Human Services and to identify best practices that will reduce unnecessary
32	reliance on large juvenile correctional facilities and promote the
33	development of an appropriate continuum of community-based treatment
34	alternatives in the least restrictive settings possible consistent with
35	public safety; and

1 WHEREAS, an interim study proposal is required for the retention of 2 independent expert consultants to assist the Division of Youth Services of 3 the Department of Health and Human Services to conduct comprehensive needs 4 and risk assessments of juveniles incarcerated at the Alexander Juvenile 5 Correctional Facility and other facilities of the Division of Youth Services 6 of the Department of Health and Human Services to identify gaps in existing 7 community-based alternative placements and services necessary to more 8 effectively and efficiently serve juveniles committed to the Division of 9 Youth Services of the Department of Health and Human Services in the least 10 restrictive settings possible consistent with public safety; and

12 WHEREAS, there is a pressing need to develop a juvenile justice reform 13 plan by no later than twelve (12) months from the effective date of this 14 interim study proposal that incorporates the evaluations, assessments, and 15 recommendations of the independent experts provided for by this interim study 16 proposal and other stakeholders, including the Juvenile Justice Center of the 17 University of Arkansas at Little Rock, the Department of Education, the 18 Division of Behavioral Health of the Department of Health and Human Services, 19 the Division of Developmental Disabilities Services of the Department of 20 Health and Human Services, Arkansas Advocates for Children and Families, the 21 Arkansas Disability Rights Center, the Juvenile Ombudsman Division of the 22 Public Defender Commission, the Division of Children and Family Services of 23 the Department of Health and Human Services, the Administrative Offices of 24 the Courts, and families and youth; and

26 WHEREAS, there exists an urgent need for construction, renovation, 27 acquisition, purchase of equipment, maintenance, and other operating expenses 28 to implement the reform plan provided for in this interim study proposal and 29 to replace the facilities where conditions of confinement support ceasing 30 operation with facilities that meet contemporary juvenile justice national 31 best practices. These treatment services, programs, and centers shall 32 incorporate best practices for the provision of rehabilitative and other 33 services for juveniles and be consistent with applicable standards of accreditation from the American Correctional Association, 34

THAT the Senate requests that the Senate Interim Committee on Children and Youth and the House Interim Committee on Aging, Children and Youth, Legislative and Military Affairs study ways to improve the state's juvenile justice system for youth committed to the Division of Youth Services of the Department of Health and Human Services.
