31	(4) Ensure that violations of Arkansas animal cruelty laws
32	remain a misdemeanor except in extreme cases of cruelty to dogs, cats, and

34	(5) Oppose legislation and rules that would prohibit or unduly
35	restrict the use of animals in research.

6	(A) Intended to cause extreme physical pain; and
7	(B) Done or carried out in an especially depraved or

9	(2) "Pet" means any domesticated animal that is normally
10	maintained in or near a household and that is dependent upon the care of a
11	human.
12	(b) A person is guilty of aggravated cruelty to pets if, with no
13	justifiable purpose, he or she intentionally kills or intentionally causes
14	serious physical injury to a pet with aggravated cruelty.
15	(c) This section does not prohibit or interfere in any way with anyone
16	lawfully engaged in:
17	<u>(1) Hunting, trapping, fishing, or any activity approved by the</u>
18	<u>Arkansas State Game and Fish Commission;</u>
19	(2) The killing of rabid or diseased animals or of animals
20	<u>posing a threat to human safety;</u>
21	(3) Protecting livestock and poultry as authorized by § 20-10-
22	<u>102 or any other animal raised for commercial consumption or use;</u>
23	(4) Engaging in practices lawful under the Arkansas Veterinary
