11	<u>An RFID tag shall not be used for the purpose of gathering or</u>
12	<u>disseminating information related to the demographics of the purchaser of a</u>
13	product by any person or entity after the product is:
14	(1) Sold at the retail level; and
15	(2) Removed from the premises of the retail establishment that
16	<u>is the site of the sale.</u>
