9	WHEREAS, access to dental care continues to be a serious problem across Arkansas; and		
10			
11	WHEREAS, a report by the United States Surgeon General describes health care as the		
12	"silent epidemic of oral disease affecting our most vulnerable citizens"; and		
13			
14	WHEREAS, dental disease leads not only to tooth loss, but may contribute to coronary		
15	heart disease, diabetes, pre-term low birth-weight babies, and the disruption of a child's ability to		
16	learn; and		
17			
18	WHEREAS, Arkansas does not have an in-state dentistry education program, but instead		
19	pays other states to educate dentists who will practice in Arkansas,		
20			
21	NOW THEREFORE,		
22	BE IT PROPOSED BY THE LEGISLATIVE COUNCIL OF THE EIGHTY-SIXTH		
23	ARKANSAS GENERAL ASSEMBLY:		
24			
25	THAT the House and Senate Interim Committees on Public Health, Welfare, and Labor		
26	study the need for a school of dentistry at the University of Arkansas for Medical Sciences.		
27			
28	BE IT FURTHER PROPOSED that the study proposed in this Interim Study Proposal		
29	shall :		
30	(1) Include a comparison of the number of dentists and other dental health care		
31	personnel in Arkansas to comparable states, and project future needs in Arkansas;		
32	(2) Describe access by Arkansans to programs and colleges that educate dentists		
33	and other dental health care personnel;

1	(3) Recommend future actions to assure an adequate dental health care workforce		
2	for Arkansas; and		
3	(4) Provide regular reports to the interim committees and a final report not later		
4	than September 15, 2008.

6	BE IT FURTHER PROPOSED that the House and Senate Interim Committees on Public		
7	Health, Welfare and Labor work in conjunction with the Area Health Education Centers Program		
8	of the University of Arkansas for Medical Sciences to study the adequacy of the dental health care		
9	workforce in Arkansas.
