20	THE ARKANSAS APLARY ACT OF 2009.
21	
22	
23	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25	SECTION 1. Arkansas Code Title 2, Chapter 22 is amended to add an
26	additional subchapter to read as follows:
27	<u>2-22-201. Title.</u>
28	This subchapter shall be known and may be cited as the "Arkansas Apiary
29	<u>Act of 2009".</u>
30	
31	2-22-202. Findings.
32	The General Assembly finds that:
33	(1) Honeybees are kept in beehives by beekeepers throughout the
34	state, and feral colonies of honeybees have established nests, including
35	nests in hollow trees and in the walls of buildings;
36	(2) Honeybees perform a pollination function that is essential to



1	the propagation of many species of flowering plants in this state;
2	(3) Flowering plants that benefit from pollination include many
3	agricultural crops, wildflowers, and forest plants of importance to all
4	Arkansans, and the honeybees are the major pollinator for most of those
5	plants; and
6	(4) The state should take appropriate action to ensure the
7	continued availability of an adequate population of honeybee pollinators.
8	
9	<u>2-22-203. Definitions.</u>
10	As used in this subchapter:
11	(1) "Apiary" means a place where one (1) or more colonies or
12	nuclei of bees are kept;
13	(2) "Apiary equipment" means equipment used in the handling or
14	manipulation of bees, honey, beeswax, and hives;
15	(3) "Bee" means any subspecies of Apis mellifera;
16	(4) "Beekeeper" means an individual, person, firm, association,
17	partnership, corporation, or other entity that owns, possesses, or controls
18	an api ary;
19	(5) "Bee disease" means a disease or abnormal condition of the
20	<u>eggs, larvae, pupae, or adult stage of bees;</u>
21	(6) "Bee pest" means an organism that is harmful to a bee;
22	(7) "Bee product" means a product produced by a bee, including
23	without limitation beeswax, honey, pollen, royal jelly, and propolis;
24	(8) "Certificate of health" means an official document issued by
25	the State Plant Board or a corresponding agency of another state or nation
26	that certifies that bees, an apiary, or apiary equipment does not have a bee
27	<u>disease or a bee pest;</u>
28	(9) "Colony" means an aggregate of worker bees, drones, the
29	queen, and developing young bees that live together in a hive or other
30	dwelling;
31	(10) "Commercial beekeeper" means a beekeeper that owns or
32	operates three hundred (300) or more colonies;
33	(11) "Feral colony" means a colony that is not kept in a hive
34	provided by a beekeeper and whose nest is usually located in a cavity;
35	(12) "Hive" means a receptacle or container or any part of a
36	receptacle or container that is used as a domicile for bees:

1	(13) "Inspection report" means a document issued by an agent of
2	the board or a corresponding agency of another state or nation that states:
3	(A) That bees, an apiary, or apiary equipment has been
4	inspected; and
5	(B) The results of the inspection;
6	(14) "Move" means to ship bees, to offer to ship bees by a common
7	carrier, to receive bees for transportation, or to allow bees to be moved by
8	any person and by any means;
9	(15) "Nucleus" means any division or portion of a colony that
10	<u>contains a comb;</u>
11	(16) "Nuisance" means a bee disease, a bee pest, or a hive that
12	cannot be readily inspected;
13	(17) "Package" means an indefinite number of bees in a bee-tight
14	container with or without a queen and without a comb;
15	(18) "Pollination" means the use of a bee to transfer pollen in
16	the production of agricultural crops;
17	(19) "Section head" means the Head of the Apiary Section of the
18	Division of Plant Industries of the State Plant Board;
19	(20) "State apiarist" means the Director of the Division of
20	<u>Plant Industries of the State Plant Board or a person who holds a</u>
21	corresponding position in another state or nation; and
22	(21) "State inspector" means a person employed by the board to
23	inspect apiaries and to perform other duties assigned by the board.

25	<u>2-22-204. Administration – Fees – Personnel.</u>
26	(a) The State Plant Board shall administer this subchapter.
27	<u>(b)(1) The board may establish reasonable fees for the administration</u>
28	<u>of this subchapter.</u>
29	(2) Moneys collected from fees under this subchapter shall be
30	paid into the Plant Board Fund, § 19-6-408.
31	(c) The section head shall be responsible for developing and
32	implementing the apiary program established under this subchapter.
33	(d) The board may appoint assistants, state inspectors, and other
34	employees to carry out the apiary program established under this subchapter.
35	
36	2-22-205. Beekeeper Advisory Committee.

1	(a) The State Plant Board shall establish a Beekeeper Advisory
2	Committee to advise the board on issues affecting bees and beekeepers.
3	(b)(1) The committee shall consist of commercial and noncommercial
4	beekeepers.
5	(2) The board shall ensure that the membership of the committee
6	<u>is:</u>
7	(A) Representative of the diverse interests in the
8	beekeeping industry; and
9	(B) Large enough to provide the board with a comprehensive
10	view of the needs of the beekeeping industry.
11	
12	2-22-206. Cooperative agreement.
13	(a) The State Plant Board may enter into a cooperative agreement or
14	grant, or both, for an inspection under this subchapter with the following:
15	(1) Beekeeper;
16	(2) Person;
17	(3) Municipality;
18	(4) County;
19	(5) State agency;
20	(6) Board of another state or the United States;
21	(7) Official of another state or the United States; or
22	(8) Authority of another state or the United States.
23	(b) The cooperative agreement or grant for an inspection may concern
24	bee diseases and bee pests, the monitoring or control efforts for bee
25	diseases and bee pests, and educational programs regarding the beekeeping
26	industry.
27	
28	2-22-207. Registration.
29	The registration of a colony with the State Plant Board is voluntary.
30	
31	2-22-208. Apiary equipment.
32	(a) A beekeeper shall provide movable frames for the inspection of a
33	<u>hi ve.</u>
34	(b)(1) A beekeeper that has a colony or nucleus living in a hive or
35	other container that does not have movable frames is a nuisance.
36	(2)(A) If the State Plant Board finds a nuisance, the board shall

1	order the transfer of the colony or nucleus to a hive with movable frames
2	within the time period set by rule.
3	(B) If a beekeeper does not make the transfer under
4	subdivision (b)(2)(A) of this section within the specified time period, the
5	board may confiscate the bees and the hive or other container of bees.
6	
7	2-22-209. Inspection - Sale, movement, and delivery of bees.
8	(a) A state inspector:
9	(1) May enter on any private or public property:
10	(A) To ascertain the existence of a bee disease or a bee
11	<u>pest;</u>
12	(B) For the purpose of:
13	(i) Inspecting, supervising an inspection, taking
14	samples, and examining and creating records of a hive, nucleus, or colony; or
15	<u>(ii) Treating, removing, or destroying a hive,</u>
16	nucleus, colony, or articles that may be infected by a bee disease or a bee

18	(2)(A) Shall give a beekeeper at least five (5) days' notice of

30	(2) If an apiary has been inspected at the request of a
31	beekeeper and the state inspector finds it to be free from a dangerous,
32	contagious, or infectious bee disease or a bee pest and the beekeeper has
33	complied with the other provisions of this subchapter, the state inspector
34	shall issue an inspection report at the site of the apiary.
35	(d)(1) Bees or a hive can be offered for sale, moved, or sold within
36	this state without a certificate of health or certificate of inspection.

1	(2) A commercial beekeeper engaged in the business of selling
2	queens, a package, or a hive shall be inspected annually.
3	(e)(1) A beekeeper that is aggrieved by an action of a state inspector
4	may appeal to the section head within sixty (60) days after the state

6	(2) If a beekeeper appeals a decision by the section head, the
7	Apiary Committee shall grant a hearing to the aggrieved beekeeper.

9	<u>2-22-210. Penal ti es.</u>
10	<u>(a) The State Plant Board may assess a civil penalty under this</u>
11	subchapter in a proceeding under § 2-16-203(b) if a person:
12	(1) Violates a provision of this subchapter, a rule promulgated
13	under this subchapter, or an order or a notice issued under this subchapter;
14	(2) Forges, counterfeits, destroys, or wrongfully or
15	fraudulently uses any certificate, notice, or other document created under
16	<u>this subchapter;</u>
17	(3) Knowingly gives false or misleading information in any
18	matter pertaining to the enforcement of this subchapter; or
19	(4) Impedes, hinders, or otherwise prevents or attempts to
20	prevent the Director of the State Plant Board, the state apiarist, the
21	<u>section head, or a state inspector from performing his or her official duty</u>

28	Inspector Program to train and certify a volunteer in the fundamentals of

30	(2) A certified voluntary inspector:
31	(A) May assist with the apiary inspection program created
32	under this subchapter;
33	(B) Shall work under the supervision of a state inspector;
34 25	and (c) Shall not excite the increation of his on her colory
35	(C) Shall not assist the inspection of his or her colony
36	or nucleus.

1	(b) The Section Head shall administer the Certified Voluntary
2	Inspector Program.
3	
4	<u>2-22-212. Rul es.</u>
5	The State Plant Board shall:
6	(1) After soliciting comment from the Beekeeper Advisory Committee,
7	promulgate rules to implement this subchapter;
8	(2) Promulgate rules to:
9	(A) Establish and implement a program for the inspection
10	of an apiary in this state to detect a bee disease or a bee pest;
11	(B) Provide guidelines for the inspection of a beekeeper;
12	and
13	(C) Specify the format and contents for an inspection
14	report; and
15	(3) Establish minimum competency standards for a person to be employed
16	as a state inspector, including without limitation:
17	(A) A demonstrated ability to properly handle hives and bees;
18	(B) Proficiency in the recognition of bee diseases and bee
19	pests; and
20	(C) A substantial understanding of the administration of the
21	apiary programs administered under this subchapter.
