**For An Act To Be Entitled**

AN ACT TO AUTHORIZE A COUNTY RECORDER OF DEEDS TO  
OBTAIN, SELL, AND AFFIX DOCUMENTARY STAMPS TO  
DEEDS PRESENTED FOR RECORDING OR OTHERWISE ASSIST  
COMPLIANCE WITH THE REAL PROPERTY TRANSFER TAX;  
AND FOR OTHER PURPOSES.

**Subtitle**

TO AUTHORIZE A COUNTY RECORDER OF DEEDS  
TO OBTAIN, SELL, AND AFFIX DOCUMENTARY  
STAMPS TO DEEDS PRESENTED FOR RECORDING  
OR OTHERWISE ASSIST COMPLIANCE WITH THE  
REAL PROPERTY TRANSFER TAX.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Arkansas Code § 14-15-408 is amended to read as follows:  
14-15-408. Tender of fees required.

(a) ~~No A recorder shall be~~ is not required to endorse any instrument  
presented to him or her for record as filed or to record the instrument  
unless the fees for recording and the tax thereon, if any, are first tendered  
to him or her; nor shall any recorder be subject to any action or liable in  
any manner for a failure or refusal to record any instrument unless the fees  
are first tendered.

(b) If sufficient fees are tendered to pay the recording fee and the



1 real property transfer tax required by § 26-60-101 et seq., the recorder  
2 shall affix the appropriate amount of documentary stamps to the instrument  
3 and record the instrument.

5 SECTION 2. Arkansas Code § 26-60-109 is amended to read as follows:  
6 26-60-109. Documentary stamps.

7 The Director of the Department of Finance and Administration shall  
8 design documentary stamps in appropriate denominations and shall make the  
9 stamps available for purchase at offices of the Revenue Division of the  
10 Department of Finance and Administration and by consignment arrangement with  
11 county recorders of deeds, title companies, banks, and savings and loans  
12 associations throughout the state.
