AN ACT CONCERNING THE MEMBERSHIP OF THE STATE
PLANT BOARD; AND FOR OTHER PURPOSES.

Subtitle

CONCERNING THE MEMBERSHIP OF THE STATE
PLANT BOARD.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Arkansas Code § 2-16-206(a), concerning the membership of
the State Plant Board, is amended to read as follows:

(a) There is created and established a State Plant Board, composed of
sixteen (16) members, as follows:

(1) The head of the Department of Entomology, University of
Arkansas Dale Bumpers College of ~~Agriculture~~, Agricultural, Food and Life
Sciences, who shall be a non-voting member of the board;

(2) The head of the Department of Plant Pathology, University of
Arkansas Dale Bumpers College of ~~Agriculture~~ Agricultural, Food and Life
Sciences;

(3) A practical cotton grower, actively engaged in the business,
to be appointed by the Governor;

(4) One (1) member to represent the Arkansas fertilizer and
cotton oil mills, actively engaged in the business, to be appointed by the
Governor;

1 (5) A practical rice grower, actively engaged in the business,
2 to be appointed by the Governor;

3 (6) A practical horticulturist, actively engaged in the
4 business, to be elected by the Arkansas State Horticultural Society;

5 (7) A nurseryman, actively engaged in the business, to be
6 elected by the Arkansas Green Industry Association;

7 (8) A practical seed grower, actively engaged in the business,
8 to be elected by the Arkansas Seed Growers Association;

9 (9) A pest control operator, actively engaged in the business,
10 to be elected by the Arkansas Pest Control Association, Inc.;

11 (10) A seed dealer, actively engaged in the business, to be
12 elected by the Arkansas Seed Dealers Association;

13 (11) A feed manufacturer, actively engaged in the business, to
14 be elected by the Arkansas Feed Manufacturers Association;

15 (12) A pesticide manufacturer, actively engaged in the business,
16 to be elected by the Arkansas Agricultural Pesticide Association;

17 (13) One (1) member to represent the Arkansas Agricultural
18 Aviation Association, to be elected by the Arkansas Agricultural Aviation
19 Association;

20 (14) One (1) member to represent the Arkansas Forestry
21 Association, to be elected by the Arkansas Forestry Association; and

22 (15) Two (2) farmers actively and principally engaged in farming
23 in this state, appointed by the Governor.
