28	(a)(l)(A) The board of directors of each school district, open-
29	enrollment public charter school, and education service cooperative annually
30	shall prepare a budget of expenditures and receipts that <u>complies with normal</u>
31	budgetary guidelines established by the State Board of Education and which
32	shall be filed with the Department of Education by September 30 of each year
33	under this subchapter.
34	(B) A school district, open-enrollment public charter
35	school, or education service cooperative that wishes to deviate from normal
36	budgetary guidelines may request a waiver from the department.
