19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 23-112-614(b)(2), regarding salvage auction
22 buyer's identification cards, is amended to read as follows:

23 (2)(A) The department shall issue the salvage auction buyer's
24 identification card at a fee not to exceed:

25 ~~(A) Thirty five~~ thirty-five dollars (\$35.00) for the first
26 card issued to the cardholder and fifty dollars (\$50.00) for the second card
27 issued to the cardholder if the cardholder is:

28 ~~(i) An Arkansas resident dealer or wrecker; and~~

29 ~~(ii) At~~ at least one (1) of the following:

30 ~~(a)(i)~~ A licensed new motor vehicle dealer;

31 ~~(b)(ii)~~ A licensed used motor vehicle dealer; or

32 ~~(c)(iii)~~ A licensed wrecker; ~~or~~

33 ~~(B) Three hundred fifty dollars (\$350) for the first card~~
34 ~~issued to the cardholder and two hundred fifty dollars (\$250) for the second~~
35 ~~card issued to the cardholder if the cardholder is:~~

36 ~~(i) An out of state resident; and~~

1 ~~(ii) Licensed by another state as a motor vehicle~~
2 ~~dealer or wrecker and meets the requirements of the department.~~

3 (B) If the licensed new motor vehicle dealer, licensed
4 used motor vehicle dealer, or licensed wrecker is an out-of-state resident
5 and licensed under the laws of another state, the department may promulgate
6 procedures to verify that the license presented is current and valid.
