21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22	
23	SECTION 1. Arkansas Code Title 4, Chapter 88, is amended to add an
24	additional subchapter to read as follows:
25	<u>4-88-901. Title.</u>
26	This subchapter shall be known and may be cited as the "Restocking Fee
27	<u>Act".</u>
28	
29	<u>4-88-902. Definitions.</u>
30	<u>As used in this subchapter:</u>
31	(1) "Customer" means a purchaser or potential purchaser of
32	goods;
33	(2) "Goods" means tangible property that is offered for sale or
34	<u>lease;</u>
35	(3) "Restocking fee" means a fee charged directly or indirectly
36	by a retail business to its customers to replenish its supply of goods upon

1	the return or exchange of the goods;
2	(4) "Retail business" means a seller or lessor of goods; and
3	(5) "Retail price" means the actual cost of goods sold or
4	<u>leased.</u>
5	
6	4-88-903. Limitation on restocking fee Requirements.
7	If a retail business charges a restocking fee, the restocking fee
8	<u>shall:</u>
9	(1) Not exceed ten percent (10%) of the retail price at the time
10	of purchase of the goods for which the restocking fee is charged; and
11	(2) Be disclosed under § 4-88-904.
12	
13	4-88-904. Disclosure of restocking fee.
14	(a) A retail business in this state that charges a restocking fee
15	shall disclose the restocking fee by posting notice of the amount of the
16	restocking fee and the goods subject to the restocking fee:
17	(1) On a customer's sales receipt printed in blue, bold, and a
18	type at least the size of the other retail information;
19	<u>(2) On each in-store cash register;</u>
20	(3) In conspicuous areas throughout the retail store and at each
21	entrance and exit;
22	(4) In print advertising and promotional materials; and
23	(5) On the website of the retail business.
24	(b) The notice shall disclose the retail business's restocking fee
25	policy or advise customers where to obtain the full restocking fee policy.
26	(c) The notices and disclosure shall be printed in at least one inch
27	(1") type and in a clear and conspicuous manner.
28	
29	<u>4-88-905. Enforcement.</u>
30	<u>A violation of this subchapter is a deceptive and unconscionable trade</u>
31	practice subject to the penalties, remedies, and enforcement provided by § 4-
32	<u>88-101 et seq.</u>
33
