23	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25	SECTION 1. Arkansas Code Title 5, Chapter 52, Subchapter 1 is amended
26	to add a new section to read as follows:
27	5-52-109. Illegal disbursement of funds by a circuit court or district
28	court judge.
29	(a)(l) A circuit court or district court judge who knowingly receives
30	and disburses funds in his or her capacity as a circuit court or district
31	court judge to a person or entity not authorized by law to receive the
32	disbursement upon conviction is guilty of a Class A misdemeanor.
33	(2) A second or subsequent violation of this section is a Class
34	<u>D felony.</u>

1	(b) In addition to a fine under this section, the sentencing court
2	shall order the circuit court or district court judge to make restitution of
3	all funds illegally disbursed.
4	
5	SECTION 2. Arkansas Code Title 16, Chapter 10, Subchapter 4 is amended
6	to add a new section read as follows:
7	16-10-139. Judicial prohibition against payments to a public defender
8	or prosecuting attorney.
9	<u>A judge shall not make payments for services rendered to a public</u>
10	defender, assistant public defender, prosecuting attorney, or deputy
11	prosecuting attorney resulting from the exercise of that person's official
12	duties.
