17	TO AMEND THE DISTRIBUTION OF SCHOLARSHIP
18	AWARDS UNDER THE ARKANSAS ACADEMIC
19	CHALLENGE SCHOLARSHIP PROGRAM, PART 2;
20	AND TO DECLARE AN EMERGENCY.

23	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24	
25	SECTION 1. Arkansas Code § 6-85-204, concerning definitions for the
26	Arkansas Academic Challenge Scholarship Program, Part 2, is amended to add an
27	additional subdivision to read as follows:
28	(23) "Two-year approved institution of higher education" means
29	an approved:
30	(A) Technical college or community college under the
31	Arkansas Technical and Community College System;
32	(B) Branch campus of a four-year approved institution of
33	higher education; or
34	(C) Nursing school.

1 SECTION 2. Arkansas Code § 6-85-212(e)(1), concerning the scholarship 2 award amount for a full-time recipient at a four-year institution of higher education, is amended to read as follows: 3 4 (e)(1)(A) Beginning with the 2011-2012 2013-2014 academic year, the 5 Department of Higher Education shall distribute scholarship award amount 6 awards under this subchapter for an academic year for a full-time traditional 7 or nontraditional recipient enrolled in a four year approved institution of 8 higher education is four thousand five hundred dollars (\$4,500) as provided 9 under § 6-85-222. 10 SECTION 3. Arkansas Code § 6-85-212(e)(2)(A), concerning scholarship 11 12 award amounts, is amended to read as follows: (2)(A) The department shall award an aggregate amount of 13 14 scholarship awards to nontraditional students beginning with the 2010-2011 academic year of twelve million dollars (\$12,000,000), plus any additional 15 16 amount authorized by law. 17 18 SECTION 4. Arkansas Code § 6-85-212(e)(3) is repealed. 19 (3) The scholarship award for a full-time student enrolled in 20 one (1) of the following institutions of higher education is one-half $(\frac{1}{2})$ of 21 the scholarship award amount for a full-time undergraduate student enrolled 22 in a four-year approved institution of higher education: (A) A two-year approved institution of higher education; 23 24 (B) A branch campus of a four-year approved institution of 25 higher education; or 26 (C) An approved nursing school. 27 SECTION 5. Arkansas Code Title 6, Chapter 85, Subchapter 2, is amended 28 29 to add an additional section to read as follows: 30 6-85-222. Scholarship award distribution. (a) The Department of Higher Education shall award scholarships under 31 32 this subchapter for an academic year but shall distribute the awards as 33 provided under this section after the last day to drop a class at an approved 34 institution of higher education in each fall and spring semester. (b) For a recipient who has a minimum composite ACT score of twenty-35 36 one (21) or higher or the equivalent score on an ACT equivalent and a high

1	school grade point average of 2.75 or higher if enrolled in the first
2	semester as a first-time freshman or a postsecondary grade point average of
3	2.75 or higher if enrolled in a subsequent semester, the annual scholarship
4	award amount is:
5	(1) Two thousand two hundred fifty dollars (\$2,250) for a
6	recipient to attend a two-year approved institution of higher education,
7	distributed as:
8	(A) One thousand dollars (\$1,000) in the first semester
9	the recipient is enrolled; and
10	(B) One thousand two hundred fifty dollars (\$1,250) in the
11	second semester the recipient is enrolled; and
12	(2)(A) Three thousand five hundred dollars (\$3,500) for a
13	recipient to attend a four-year approved institution of higher education,
14	distributed as one thousand seven hundred fifty dollars (\$1,750) each
15	semester.
16	(B) A recipient under subdivision (b)(1) of this section
17	who attends two (2) years at a two-year approved institution of higher
18	education and maintains or exceeds a minimum postsecondary grade point
19	average of 2.75 may transfer to a four-year approved institution of higher
20	education and receive the scholarship award amount under subdivision
21	(b)(2)(A) of this section.
22	(c) For a recipient who has a minimum composite ACT score of nineteen
23	(19) or twenty (20) or the equivalent score on an ACT equivalent and a high
24	school grade point average of 2.50 or higher if enrolled in the first
25	semester as a first-time freshman or a postsecondary grade point average of
26	2.50 if enrolled in a subsequent semester, the annual scholarship award
27	amount is:
28	(1) Two thousand two hundred fifty dollars (\$2,250) for a
29	recipient to attend a two-year approved institution of higher education in
30	the recipient's first year of enrollment, distributed as:
31	(A) Eight hundred dollars (\$800) in the first semester of
32	each year; and
33	(B) One thousand four hundred fifty dollars (\$1,450) in
34	the second semester of each year;
35	(2) One thousand dollars (\$1,000) for a recipient to attend a
36	four-year approved institution of higher education in the recipient's first

1	year of enrollment, distributed as five hundred dollars (\$500) in each
2	semester;
3	(3) One thousand five hundred dollars (\$1,500) for a recipient
4	to attend a four-year approved institution of higher education in the
5	recipient's second year of enrollment, distributed as seven hundred fifty
6	dollars (\$750) each semester;
7	(4) Three thousand five hundred dollars (\$3,500) for a recipient
8	to attend a four-year approved institution of higher education in the
9	recipient's third year of enrollment, distributed as:
10	(A) One thousand five hundred dollars (\$1,500) in the
11	first semester; and
12	(B) Two thousand dollars (\$2,000) in the second semester;
13	and
14	(5) Four thousand five hundred dollars (\$4,500) for a recipient
15	to attend a four-year approved institution of higher education in the
16	recipient's fourth year of enrollment, distributed as:
17	(A) Two thousand dollars (\$2,000) in the first semester;
18	and
19	(B) Two thousand five hundred dollars (\$2,500) in the
20	second semester.
21	(d) First and second semesters shall be consecutive except that the
22	following semesters are not counted:
23	(1) A summer semester; or
24	(2) A semester for which the department has granted a waiver of
25	continuing eligibility and the student is not enrolled.
26	(e)(l) The department shall not distribute funds in the second
27	semester of an academic year if the recipient has not maintained continuing
28	eligibility for the scholarship for the second semester.
29	(2) Scholarship award amounts that are not paid in the second
30	semester of an academic year due to a recipient's failure to maintain
31	continuing eligibility shall be added to the aggregate amount of scholarship
32	awards for nontraditional students under § 6-85-212(e)(2).
33	
34	SECTION 6. EMERGENCY CLAUSE. It is found and determined by the
35	General Assembly of the State of Arkansas that increasing the number of
36	Arkansans obtaining postsecondary credentials is critical to the economic

1	health of the state and its citizens; that the Arkansas Scholarship Lottery
2	provides the opportunity for tens of thousands of Arkansans to obtain
3	postsecondary education; that the deadline for scholarship applications is
4	June 1, 2013; that the financial integrity of the Arkansas Scholarship
5	Lottery is critical to the continued existence of the scholarships; and that
6	this act is immediately necessary because the Department of Higher Education
7	must promulgate rules to implement this act before June 1, 2013, in order to
8	provide eligible Arkansans the opportunity to apply for the scholarship.
9	Therefore, an emergency is declared to exist, and this act being immediately
10	necessary for the preservation of the public peace, health, and safety shall
11	become effective on:
12	(1) The date of its approval by the Governor;
13	(2) If the bill is neither approved nor vetoed by the Governor,
14	the expiration of the period of time during which the Governor may veto the
15	bill; or
16	(3) If the bill is vetoed by the Governor and the veto is
17	overridden, the date the last house overrides the veto.
