24	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

26	SECTION 1. Arkansas Code § 5-4-301, concerning crimes for which
27	suspension or probation is prohibited, is amended to add a new subsection to
28	read as follows:
29	(e) A court shall not suspend imposition of sentence as to a term of
30	imprisonment for a felony offense that requires registration as a sex
31	offender under the Sex Offender Registration Act of 1997, § 12-12-901 et seq.
32	
33	SECTION 2. Arkansas Code Title 16, Chapter 90, Subchapter 1, is
34	amended to add a new section to read as follows:
35	16-90-123. Sentences for sex offenses not involving incarceration.

1	(a) A person sentenced for a felony conviction that would require
2	registration as a sex offender under the Sex Offender Registration Act of
3	1997, § 12-12-901 et seq., but that does not include incarceration in the
4	Department of Correction as a part of the sentence is not eligible for a
5	suspended sentence under § 16-90-115 or a suspended imposition of sentence
6	and shall be sentenced to supervised probation under § 16-93-301 et seq.
7	(b) A term of incarceration in a county or regional jail as a
8	condition of probation is permitted under this section.
