17	TO ENCOURAGE OVERSIGHT OF STATE AGENCIES;
18	TO REQUIRE PERIODIC REVIEW OF ALL STATE
19	AGENCIES; AND TO PROVIDE RECOMMENDATIONS
20	TO STATE AGENCIES TO PREVENT WASTE.
21

23	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24	
25	SECTION 1. Intent.
26	(a) The General Assembly finds that:
27	(1) The actions of state government have produced a substantial
28	increase in the number of agencies, departments, boards, commissions,
29	institutions, and programs of this state, growth of preexisting programs, and
30	the proliferation of rules;
31	(2) The growth of state government has developed without
32	sufficient legislative oversight, regulatory accountability, or a system of
33	checks and balances; and
34	(3) By establishing a system for the study, review,
35	recommendation, alteration, continuation, or termination of such agencies,
36	state government will be in a better position to evaluate whether agencies,

.

1	departments, boards, commissions, institutions, and programs of the state
2	government remain cost effective and perform their intended functions.
3	(b) The intent of this act is to establish an orderly schedule for the
4	review of all existing state agencies during a twelve-year period, and to
5	make provision for review by the State Agency Efficiency and Accountability
6	Review Subcommittee of the Joint Performance Review Committee to enable the
7	General Assembly to have the benefit of recommendations for the efficient
8	continuation of those state agencies.
9	
10	SECTION 2. Arkansas Code Title 25 is amended to add an additional
11	chapter to read as follows:
12	CHAPTER 43
13	STATE AGENCY EFFICIENCY AND ACCOUNTABILITY ACT
14	
15	25-43-101. Short title.
16	This chapter shall be known as the "State Agency Efficiency and
17	Accountability Act".
18	
19	25-43-102. Definitions.
20	As used in this chapter:
21	(1) "State agency" means any department, agency, board,
22	commission, office, or other authority of the State of Arkansas.
23	(2) "Subcommittee" means the State Agency Efficiency and
24	Accountability Review Subcommittee of the Joint Performance Review Committee;
25	and
26	
27	25-43-103. State Agency Efficiency and Accountability Review
28	Subcommittee.
29	(a) There is created the State Agency Efficiency and Accountability
30	Review Subcommittee.
31	(b)(1)(A) The subcommittee shall be a subcommittee of the Joint
32	Performance Review Committee.
33	(B) During legislative sessions, the subcommittee is
34	authorized to meet as a subcommittee of the Joint Performance Review
35	<u>Committee.</u>

1	(2) The voting membership of the subcommittee shall be composed
2	<u>of:</u>
3	(A) Up to a maximum of seven (7) House members appointed
4	by the Speaker of the House from the membership of the House Joint
5	Performance Review Committee; and
6	(B) Up to a maximum of seven (7) Senate members appointed
7	by the Chair of the Senate Joint Performance Review Committee.
8	(3) The voting members of the subcommittee shall be no more than
9	the voting members of the Joint Performance Review Committee.
10	(4) The nonvoting membership shall consist of the following:
11	(A) The Executive Director of the Arkansas State Employees
12	Association;
13	(B) The Director of the Arkansas Public Employees'
14	Retirement System;
15	(C) The Director of the Department of Finance and
16	Administration or an agency deputy director as designated by the director;
17	(D) The Director of the Office of Personnel Management of
18	the Division of Management Services of the Department of Finance and
19	Education; and
20	(E) Two (2) executive branch appointees that shall serve
21	one-year terms and may be reappointed for a maximum of three (3) years.
22	(5)(A) The House cochair and vice chair of the subcommittee
23	shall be determined by the Speaker of the House and shall be from the
24	membership of the House Performance Review Committee; and
25	(B) The Senate cochair and vice chair of the subcommittee
26	shall be determined by the chair of the Senate Performance Review Committee
27	and shall be from the Senate membership.
28	(6) For interim meetings, legislative members shall be entitled
29	to reimbursement for expenses and per diem at the same rate and from the same
30	source as provided by law for attending other meetings of the interim
31	committee and interim subcommittee.
32	
33	<u>25-43-104. Staff.</u>
34	The Bureau of Legislative Research and Legislative Council shall
35	provide staff support for the State Agency Efficiency and Accountability
36	Review Subcommittee to ensure prudent fiscal stewardship of taxpayer dollars.

2	25-43-105. State agency report to the State Agency Efficiency and
3	Accountability Review Subcommittee.
4	Before October 30 of the odd-numbered year before the year in which a
5	state agency is to be reviewed under this chapter, the state agency shall
6	report to the State Agency Efficiency and Accountability Review Subcommittee:
7	(1) Information regarding the application to the state agency of
8	the criteria in § 25-43-108; and
9	(2) Any other information that the state agency considers
10	appropriate or that is requested by the subcommittee.
11	
12	25-43-106. Subcommittee duties.
13	(a) Before September 1 of the even-numbered year before the year in
14	which a state agency subject to this chapter is to be reviewed under this
15	chapter, the State Agency Efficiency and Accountability Review Subcommittee
16	shall:
17	(1) Review and take action necessary to verify the reports
18	submitted by the state agency under § 25-43-105;
19	(2) Consult the Legislative Council, the office of the Governor,
20	the Legislative Auditor, and the Director of the Department of Finance and
21	Administration on the application to the state agency of the criteria
22	provided in § 25-43-108;
23	(3) Conduct a performance evaluation of the state agency based
24	on the criteria provided in § 25-43-108 and prepare a written report; and
25	(4) Review the implementation of subcommittee recommendations
26	contained in the reports presented to the General Assembly during the
27	preceding legislative session.
28	(b) The written report prepared by the subcommittee under subdivision
29	(a)(3) of this section shall be considered a public record.
30	
31	25-43-107. Subcommittee report.
32	(a)(1) At each regular session of the General Assembly, the State
33	Agency Efficiency and Accountability Review Subcommittee shall present to the
34	General Assembly a report on the state agencies scheduled to be reviewed on
35	June 30 of the year in which the regular session occurs.

1	(2) The General Assembly shall forward a copy of the report to
2	the Governor, the Lieutenant Governor, and the Legislative Auditor for their
3	review.
4	(b) The subcommittee shall include in the report:
5	(1) Its specific findings regarding each of the criteria
6	prescribed by § 25-43-108;
7	(2) Its recommendations based on the matters prescribed by § $25-$
8	43-109; and
9	(3) Other information the subcommittee considers necessary for a
10	complete evaluation of the state agency.
11	
12	25-43-108. Criteria for review.
13	The State Agency Efficiency and Accountability Review Subcommittee and
14	its staff shall consider the following criteria in determining whether the
15	state agency remains cost effective and performs its intended functions:
16	(1) The efficiency with which the state agency operates;
17	(2) An identification of the objectives intended for the state
18	agency and the problem or need that the state agency was intended to address,
19	the extent to which the objectives have been achieved, and any activities of
20	the state agency in addition to those granted by statute and the authority
21	for these activities;
22	(3) An assessment of less restrictive or alternate methods of
23	performing any regulation that the state agency performs that could
24	adequately protect the public;
25	(4) The extent to which the state agency is needed and is used;
26	(5) The extent to which the jurisdiction of the state agency and
27	the programs administered by the state agency overlap or duplicate those of
28	other state agencies and the extent to which the programs administered by the
29	state agency can be consolidated with the programs of other state agencies;
30	(6) Whether the state agency has recommended to the legislature
31	statutory changes calculated to be of benefit to the public rather than to an
32	occupation, a business, or an institution that the state agency regulates;
33	(7) The promptness and effectiveness with which the state agency
34	disposes of complaints concerning persons affected by the state agency;
35	(8) The extent to which the state agency has encouraged
36	participation by the public in making the state agency's rules and decisions

1	as opposed to participation solely by those the state agency regulates and
2	the extent to which the public participation has resulted in rules compatible
3	with the objectives of the state agency;
4	(9) The extent to which the state agency has complied with the
5	applicable requirements of:
6	(A) An agency of the United States or of this state
7	regarding equality of employment opportunity and the rights and privacy of
8	individuals; and
9	(B) State law and applicable rules of any state agency
10	regarding purchasing goals and programs for historically underutilized
11	businesses;
12	(10) The extent to which changes are necessary in the enabling
13	statutes of the state agency so that the state agency can adequately comply
14	with the criteria listed in this section;
15	(11) The extent to which the state agency issues and enforces
16	rules relating to potential conflicts of interest of its employees;
17	(12) The extent to which the state agency follows record
18	management practices that enable it to respond efficiently to requests for
19	public information; and
20	(13) The effect of federal intervention or loss of federal funds
21	if the state agency is abolished.
22	
23	25-43-109. Recommendations.
24	(a) In its report on a state agency, the State Agency Efficiency and
25	Accountability Review Subcommittee shall:
26	(1) Make recommendations on the continuation, termination, or
27	reorganization of each affected state agency and on the need for the
28	performance of the functions of the state agency;
29	(2) Make recommendations on the consolidation, transfer, or
30	reorganization of programs within state agencies not under review when the
31	programs duplicate functions performed in state agencies under review;
32	(3) Recommend appropriation levels for each state agency for
33	which termination or reorganization is recommended under subdivision (a)(l)
34	or subdivision (a)(2) of this section; and

1	(4) Include drafts of legislation necessary to carry out the
2	subcommittee's recommendations under subdivisions (a)(1) and (2) of this
3	section.
4	(b)(1) The General Assembly shall forward a copy of the report to the
5	Legislative Auditor.
6	(2) Based on a risk assessment of and subject to the Legislative
7	Joint Auditing Committee's approval of the recommendations, including the
8	examination in the audit plan under § 25-43-110, the Legislative Auditor may
9	examine the recommendations that do not require a statutory change and
10	include as part of the next approved audit of the state agency a report on
11	whether the state agency has implemented the recommendations and, if so, in
12	what manner.
13	
14	25-43-110. Review of certain state agencies.
15	(a) In the two-year period preceding the date scheduled for the review
16	of a state agency under this chapter, the State Agency Efficiency and
17	Accountability Review Subcommittee may exempt certain state agencies from the
18	provisions of this chapter relating to staff reports, hearings, and
19	evaluations.
20	(b) The subcommittee may exempt only state agencies that have been
21	inactive for a period of two (2) years preceding the date the state agency is
22	scheduled for review.
23	(c) The subcommittee's action in exempting state agencies under this
24	section shall be done by a majority vote of the subcommittee.
25	
26	25-43-111. Monitoring of recommendations.
27	During each regular legislative session, the State Agency Efficiency
28	and Accountability Review Subcommittee shall monitor legislation affecting
29	state agencies that have undergone review under this chapter.
30	
31	25-43-112. Subpoena power.
32	(a)(1) The State Agency Efficiency and Accountability Review
2.2	
33	Subcommittee may issue process to compel the attendance of witnesses and the
33 34	Subcommittee may issue process to compel the attendance of witnesses and the production of books, records, papers, and other objects necessary or proper

1	(2) The process may be served on a witness at any place in this
2	state.
3	(b) If a majority of the subcommittee directs the issuance of a
4	subpoena, the chair of the subcommittee shall issue the subpoena in the name
5	of the subcommittee.
6	(c) If the chair is absent, the chair's designee may issue a subpoena
7	or other process in the same manner as the chair.
8	(d)(1) If necessary to obtain compliance with a subpoena or other
9	process, the subcommittee may issue attachments.
10	(2) The attachments may be addressed to and served by any peace
11	officer in this state.
12	(e) Testimony taken under subpoena shall be reduced to writing and
13	given under oath subject to the penalty of perjury.
14	(f) A witness who attends a subcommittee proceeding under process is
15	entitled to the same mileage and per diem as a witness who appears before a
16	grand jury in this state.
17	
18	25-43-113. Assistance and access to state agencies.
19	(a)(1) The State Agency Efficiency and Accountability Review
20	Subcommittee may request the assistance of state agencies and officers.
21	(2) When assistance is requested, a state agency or officer may
22	assist the subcommittee.
23	(b) In carrying out its functions under this chapter, the subcommittee
24	or its designated staff member may inspect the records, documents, and files
25	of any state agency.
26	
27	25-43-114. Records protected from disclosure.
28	A record held by another entity that is confidential by law and that
29	the State Agency Efficiency and Accountability Review Subcommittee receives
30	in connection with the performance of the subcommittee's functions under this
31	chapter or another law remains confidential and is excepted from the Freedom
32	of Information Act of 1967, § 25-19-101 et seq.
33	
34	25-43-115. Gifts and grants.
35	(a) The State Agency Efficiency and Accountability Review Subcommittee
36	may accept gifts, grants, and donations from any organization described in

1	Section 501(c)(3) of the Internal Revenue Code as it existed on January 1,
2	2005, for the purpose of funding any activity under this chapter.
3	(b) All gifts, grants, and donations shall be:
4	(1) Accepted in an open meeting by a majority of the voting
5	members of the subcommittee; and
6	(2) Reported in the public record of the subcommittee with the
7	name of the donor and the purpose of the gift, grant, or donation.
8	
9	25-43-116. Attrition.
10	Whenever possible, state government is encouraged to utilize attrition
11	as a long-term approach to reducing state agency costs and as a means of
12	saving taxpayer money.
13	
14	25-43-117. Review of proposed legislation creating regulatory state
15	agency.
16	(a) Each bill filed in the General Assembly that would create a new
17	state agency having regulatory authority shall be forwarded to the State
18	Agency Efficiency and Accountability Review Subcommittee.
19	(b) The subcommittee shall review the bill to determine if:
20	(1) The proposed regulatory functions or other functions of the
21	state agency or committee may be administered by one (1) or more existing
22	<u>state agencies;</u>
23	(2) The form of regulation, if any, proposed by the bill is the
24	least restrictive form of regulation that will adequately protect the public;
25	(3) The bill provides for adequate public input regarding any
26	regulatory function proposed by the bill; and
27	(4) The bill provides for adequate protection against conflicts
28	of interest within the state agency.
29	(c) After reviewing the bill, the subcommittee shall forward a written
30	comment on the legislation to the sponsor of the bill and to the chair of the
31	committee to which the bill is referred.
32	
33	<u>25-43-118. Rules.</u>
34	The State Agency Efficiency and Accountability Review Subcommittee
35	shall promulgate rules necessary to carry out the provisions of this chapter.
