16	TO LIMIT THE ISSUANCE OF PERMITS FOR THE
17	OFF-PREMISES SALE OF BEER AND WINE IN
18	PROXIMITY TO CHURCHES AND SCHOOLS.

21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22	
23	SECTION 1. Arkansas Code § 3-5-207(a), concerning the scope of state
24	permits for the sale of beer and light wines is amended to read as follows:
25	(a) <u>(1)</u> Except as provided in subsection (b) of this section, any permit
26	issued under the provisions of § 3-5-206 authorizing the sale of light wines
27	or beer for consumption under the provisions prescribed in the permit shall
28	be construed to authorize the sale of such liquor by the bottle, by the glass
29	or draught, and in or from the original package.
30	(2) A new permit under this subchapter shall not be issued by
31	the Director of the Alcoholic Beverage Control Division for a business
32	located within one thousand feet (1,000') of the property line of a church or
33	schoolhouse; and
34	(3)(A) An existing permit under this subchapter shall not be
35	transferred to a location within one thousand feet (1,000') of the property
36	line of any church or schoolhouse.

1	(B) As an exception to subdivision (a)(3)(A) of this
2	section, if a business permitted for under this subchapter already exists
3	within one thousand feet (1,000') of the property line of one (1) or more
4	churches or schoolhouses, that the permit may be transferred to a new
5	location that is within one thousand feet (1,000') of the property line of
6	the closest church or schoolhouse to the present business location if the new
7	location is determined by the Alcoholic Beverage Control Division to serve
8	the public convenience and advantage.
9	
10	SECTION 2. Arkansas Code § 3-5-226, concerning the on-premises sale of
11	beer by breweries, is amended to add an additional subsection to read as
12	follows:
13	(c)(1) A new permit under this subchapter shall not be issued by the
14	Director of the Alcoholic Beverage Control Division for the location of a
15	business situated within one thousand feet (1,000') of the property line of a
16	church or schoolhouse; and
17	(2)(A) An existing permit under this subchapter shall not be
18	transferred to a location within one thousand feet (1,000') of the property
19	line of any church or schoolhouse.
20	(B) As an exception to subdivision (c)(2)(A) of this
21	section, if a business permitted under this subchapter already exists within
22	one thousand feet (1,000') of the property line of one (1) or more churches
23	or schoolhouses, that the permit may be transferred to a new location that is
24	within one thousand feet (1,000') of the property line of the closest church
25	or schoolhouse to the present business location if the new location is
26	determined by the Alcoholic Beverage Control Division to serve the public
27	convenience and advantage.
28	
29	SECTION 3. Arkansas Code § 3-5-1204, concerning licenses for
30	microbrewery-restaurants, is amended to add an additional subsection to read
31	as follows:
32	(d)(1) A new permit under this subchapter shall not be issued by the
33	director for the location of a business situated within one thousand feet
34	(1,000') of the property line of a church or schoolhouse; and

1	(2)(A) An existing permit under this subchapter shall not be
2	transferred to a location within one thousand feet (1,000') of the property
3	line of any church or schoolhouse.
4	(B) As an exception to subdivision (d)(2)(A) of this
5	section, if a business permitted under this subchapter already exists within
6	one thousand feet (1,000') of the property line of one (1) or more churches
7	or schoolhouses, that the permit may be transferred to a new location that is
8	within one thousand feet (1,000') of the property line of the closest church
9	or schoolhouse to the present business location if the new location is
10	determined by the Alcoholic Beverage Control Division to serve the public
11	convenience and advantage.
12	
13	SECTION 4. Arkansas Code § 3-5-1405, concerning licenses for small
14	breweries, is amended to add an additional subsection to read as follows:
15	(e)(l) A new permit under this subchapter shall not be issued by the
16	director for the location of a business situated within one thousand feet
17	(1,000') of the property line of a church or schoolhouse; and
18	(2)(A) An existing permit under this subchapter shall not be
19	transferred to a location within one thousand feet (1,000') of the property
20	line of any church or schoolhouse.
21	(B) As an exception to subdivision (e)(2)(A) of this
22	section, if a business permitted under this subchapter already exists within
23	one thousand feet (1,000') of the property line of one (1) or more churches
24	or schoolhouses, that the permit may be transferred to a new location that is
25	within one thousand feet (1,000') of the property line of the closest church
26	or schoolhouse to the present business location if the new location is
27	determined by the Alcoholic Beverage Control Division to serve the public
28	convenience and advantage.
29	
30	SECTION 5. Arkansas Code § 3-5-1602, concerning licensing of small
31	farm wineries, is amended to add an additional subsection to read as follows:
32	(e)(1) A new permit under this subchapter shall not be issued by the
33	Director of the Alcoholic Beverage Control Division for the location of a
34	business situated within one thousand feet (1,000') of the property line of a
35	church or schoolhouse; and

1	(2)(A) An existing permit under this subchapter shall not be
2	transferred to a location within one thousand feet (1,000') of the property
3	line of any church or schoolhouse.
4	(B) As an exception to subdivision (c)(2)(A) of this
5	section, if a business permitted under this subchapter already exists within
6	one thousand feet (1,000') of the property line of one (1) or more churches
7	or schoolhouses, that the permit may be transferred to a new location that is
8	within one thousand feet (1,000') of the property line of the closest church
9	or schoolhouse to the present business location if the new location is
10	determined by the Alcoholic Beverage Control Division to serve the public
11	convenience and advantage.
