19	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20	
21	SECTION 1. Arkansas Code § 4-29-401(b), concerning definitions under
22	the Dental Corporation Act, is amended to add an additional subdivision to
23	read as follows:
24	(4) "Nonprofit hospital" means a corporation that is:
25	(A) Organized and existing under the Arkansas Nonprofit
26	Corporation Act of 1993, § 4-33-101 et seq.;
27	(B) Recognized by the Internal Revenue Service as exempt
28	<pre>from federal taxation under 26 U.S.C. § 501(c)(3);</pre>
29	(C) A private foundation as defined under 26 U.S.C. §
30	509(a)(1); and
31	(D) Operating as a hospital as defined under 26 U.S.C. §
32	170(b)(1)(A)(iii).
33	
34	SECTION 2. Arkansas Code § 4-29-402(a), concerning the application of
35	the Arkansas Business Corporation Act, is amended to read as follows:

1	(a) <u>(l)(A)</u> The <u>Except as provided in subdivision (a)(2) of this</u>
2	section, the Arkansas Business Corporation Act of 1987, § 4-27-101 et seq.,
3	shall be applicable apply to such corporations a corporation, including their
4	its organization, except that the required number of incorporators of a
5	dental corporation shall be one (1) or more $_{\overline{\tau_j}}$ and
6	(B) they The incorporators shall enjoy the powers and
7	privileges and be subject to the duties, restrictions, and liabilities of
8	other corporations, except so far as the same may be limited or enlarged by
9	this subchapter.
10	(2) The Arkansas Business Corporation Act , § 4-27-101 et seq.,
11	does not apply to a nonprofit hospital as defined in this subchapter.
12	
13	SECTION 3. Arkansas Code § 4-29-404 is amended to read as follows:
14	4-29-404. Formation of corporation — Employee licensing required.
15	<u>(a)(1)</u> One (1) or more persons <u>A</u> person licensed pursuant to under the
16	Arkansas Dental Practice Act, § 17-82-101 et seq., may associate to form a
17	corporation pursuant to <u>under</u> the Arkansas Business Corporation Act of 1987 ,
18	§ 4-27-101 et seq., to own, operate, and maintain an establishment for the
19	study, diagnosis, and treatment of dental ailments and injuries and to
20	promote dental and scientific research and knowledge.
21	(2) However, treatment, consultation, or advice may be given by
22	employees <u>an employee</u> of the corporation only if they are <u>the employee is</u>
23	licensed pursuant to <u>under</u> the Arkansas Dental Practice Act, § 17-82-101 et
24	seq.
25	(b) A nonprofit hospital may own, operate, and maintain an
26	establishment for the study, diagnosis, and treatment of dental ailments and
27	injuries and to promote dental and scientific research and knowledge subject
28	to the requirements of subsection (c) of this section.
29	(c)(l)(A) A nonprofit hospital shall register with the Arkansas State
30	Board of Dental Examiners before operating a dental clinic or providing
31	dental services.
32	(B) A nonprofit hospital registering a dental clinic shall
33	provide to the board:
34	(i) The name of the nonprofit hospital;

1	(ii) A copy of the nonprofit hospital's
2	determination letter from the Internal Revenue Service recognizing the exempt
3	status of the nonprofit hospital under 26 U.S.C. § 501(c)(3);
4	(iii) Sites and locations where dental services are
5	to be provided by the nonprofit hospital; and
6	(iv) The identity of all persons employed by or
7	under contract with the nonprofit hospital who are required to be licensed
8	under the Arkansas Dental Practice Act, § 17-82-101 et seq.
9	(C) A nonprofit hospital shall:
10	(i) Register each location it owns, operates, or
11	maintains; and
12	(ii) Designate a licensed dentist who maintains a
13	supervisory position for the registered locations of the nonprofit hospital's
14	dental clinics.
15	(2) A person shall not practice dentistry, as defined in § 17-
16	82-102, at any dental clinic that is owned, operated, or maintained by a
17	nonprofit hospital unless the person is a dentist or dental hygienist
18	licensed under the Arkansas Dental Practice Act, § 17-82-101 et seq.
19	(3)(A) A nonprofit hospital authorized by the board to provide
20	dental services shall not direct or interfere or attempt to direct or
21	interfere with a licensed dentist's or dental hygienist's professional
22	clinical judgment and competent practice of dentistry.
23	(B) This subsection does not make it unlawful for a
24	nonprofit hospital to enforce employment contracts, corporate policy and
25	procedure manuals, quality improvement, or assurance requirements.
26	
27	SECTION 4. Arkansas Code § 4-29-405(a), concerning a corporate name
28	under the Arkansas Dental Practice Act, is amended to read as follows:
29	(a) (1) The <u>A</u> corporate name shall contain the names of one (1) or more
30	of the shareholders or, when a nonprofit hospital, the name as registered
31	with the Arkansas State Board of Dental Examiners.
32	(2) However, the name of a person who is not employed by the
33	corporation shall not be included in the corporate name, except that the name
34	of a deceased shareholder may continue to be included in the corporate name
35	for one (1) year following the decease <u>death</u> of the shareholder.

1	SECTION 5. Arkansas Code § 4-29-406 is amended to read as follows:
2	4-29-406. Officers, directors, and shareholders.
3	(a)(1) All of the officers, directors, and shareholders of a
4	corporation subject to this subchapter shall at all times be persons licensed
5	pursuant to under the Arkansas Dental Practice Act, § 17-82-101 et seq.
6	(2) No A person who is not so licensed shall not have any part
7	in the ownership, management, or control of the corporation, nor may any
8	proxy to vote any shares of the corporation be given to a person who is not
9	so licensed.
10	(b) This section does not apply to a nonprofit hospital registered by
11	the Arkansas State Board of Dental Examiners under this subchapter.
12	
13	SECTION 6. Arkansas Code § 4-29-408(c)(2), concerning a certificate of
14	registration under the Arkansas Dental Practice Act, is amended to read as
15	follows:
16	(2)(A) If the board finds that the incorporators, officers,
17	directors, and shareholders are each licensed pursuant to the Arkansas Dental
18	Practice Act, § 17-82-101 et seq., and if no disciplinary action is pending
19	before the board against any of them, and if it appears that the corporation
20	will be conducted in compliance with law and the regulations of the board,
21	the <u>The</u> board shall issue upon payment of a registration fee of twenty-five
22	dollars (\$25.00) a certificate of registration, upon payment of a
23	registration fee of twenty-five dollars (\$25.00), if the board finds:
24	(i) Each incorporator, officer, director, and
25	shareholder is licensed under the Arkansas Dental Practice Act, § 17-82-101
26	et seq., or if a nonprofit hospital, that the requirements under § 4-29-

Sales of dental services or appliances. 20 (a)(1) Any A person other than a licensed dentist or a nonprofit 21 hospital registered under the Dental Corporation Act, § 4-29-401 et seq., who 22 sells or delivers or offers to sell or deliver to the general public the 23 services of construction, repair, reproduction, duplication, alteration, 24 adjustment, cleaning, polishing, refinishing, or processing in any other 25 manner of any artificial or prosthetic tooth or teeth, bridge, crown, denture, restoration, appliance, device, structure, or material or 26 27 orthodontic appliance or material to be worn or used in the mouth is subject 28 to the penalties and liabilities prescribed in § 17-82-301(b) and (c). 29 (2) This section does not prohibit selling or delivering or 30 offering to sell or deliver any of such articles referred to in subdivision 31 (a)(1) of this section to a licensed dentist or a nonprofit hospital 32 registered under the Dental Corporation Act, § 4-29-401 et seq.
