10 AN ACT TO TRANSFER THE DIVISION OF COUNTY OPERATIONS  
11 FROM THE DEPARTMENT OF HUMAN SERVICES; AND FOR OTHER  
12 PURPOSES.

## 13 14 15 Subtitle

16 TO TRANSFER THE DIVISION OF COUNTY  
17 OPERATIONS FROM THE DEPARTMENT OF HUMAN  
18 SERVICES.

20  
21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22  
23 SECTION 1. DO NOT CODIFY. TRANSFER OF DIVISION OF COUNTY OPERATIONS  
24 OF THE DEPARTMENT OF HUMAN SERVICES.

25 (a)(1) The Division of County Operations of the Department of Human  
26 Services is transferred to the Department of County Operations by a type 2  
27 transfer under § 25-2-105.

28 (2) For the purposes of this act, the Department of County  
29 Operations shall be considered a principal department established by Acts  
30 1971, No. 38.

31 (b)(1) All authority, powers, duties, and functions as established by  
32 law for the Division of County Operations of the Department of Human  
33 Services, including all purchasing, budgeting, fiscal, accounting, human  
34 resources, payroll, legal, information systems, maintenance, program support,  
35 administrative support, and other management functions are transferred to the  
36 Department of County Operations, except as specified in this act.

1           (2)(A) All records, personnel, property, unexpended balances of  
2 appropriations, allocations, or other funds are transferred to the Department  
3 of County Operations.

4           (B) All funds shall be deposited into the Department of  
5 County Operations Fund.

6           (3) All powers, duties, and functions, including without  
7 limitation rulemaking, licensing, promulgation of rules, rates, and  
8 standards, and the rendering of findings, orders, and adjudications, as  
9 established by law for the Division of County Operations of the Department of  
10 Human Services, are transferred to the Department of County Operations,  
11 except as specified by this act.

12           (c) The Arkansas Code Revision Commission shall make appropriate name  
13 changes in the Arkansas Code to implement this act.

14  
15           SECTION 2. Arkansas Code § 11-10-111(c), concerning the protection of  
16 rights and benefits and the exception for withholding food stamp overages, is  
17 amended to read as follows:

18           (c) Any amount deducted and withheld under this section shall be paid  
19 by the director to the food stamp program administered by the ~~Division~~  
20 Department of County Operations ~~of the Department of Human Services.~~

21  
22           SECTION 3. Arkansas Code § 19-5-306(9), concerning the County  
23 Operations Fund Account of the Department of Human Services Fund, is  
24 repealed.

25           ~~(9)(A) County Operations Fund Account. The County Operations Fund~~  
26 ~~Account shall be used for the maintenance, operation, and improvement~~  
27 ~~required by the Division of County Operations of the Department of Human~~  
28 ~~Services in carrying out the powers, functions, and duties as set out in §~~  
29 ~~25-10-102.~~

30           ~~(B) The County Operations Fund Account shall consist of:~~  
31                   ~~(i) Those general revenues as may be provided by~~  
32 ~~law;~~  
33                   ~~(ii) Nonrevenue income derived from services~~  
34 ~~provided by the various programs of the Division of County Operations of the~~  
35 ~~Department of Human Services;~~

1                                   ~~(iii) Any other nonfederal grants in aids funds~~  
2 ~~provided by law;~~

3                                   ~~(iv) Funds received from the Department of Education~~  
4 ~~for surplus commodities; and~~

5                                   ~~(v) Federal reimbursement received on account of~~  
6 ~~eligible expenditures of the Division of County Operations of the Department~~  
7 ~~of Human Services;~~

8                                   ~~(C) Other federal reimbursement funds received by the~~  
9 ~~Division of County Operations of the Department of Human Services shall be~~  
10 ~~deposited into a separate federal reimbursement fund on the books of the~~  
11 ~~Treasurer of State;~~

12  
13           SECTION 4. Arkansas Code Title 19, Chapter 5, Subchapter 12, is  
14 amended to add an additional section to read as follows:

15           19-5-1258. Department of County Operations Fund.

16           (a) There is created on the books of the Treasurer of State, the  
17 Auditor of State, and the Chief Fiscal Officer of the State a miscellaneous  
18 fund to be known as the "Department of County Operations Fund".

19           (b) The fund shall consist of:

20                   (1) General revenues as may be provided by law;

21                   (2) Nonrevenue income derived from services provided by the  
22 various programs of the Department of County Operations;

23                   (3) Any other nonfederal grants-in-aid funds provided by law;

24                   (4) Funds received from the Department of Education for surplus  
25 commodities; and

26                   (5) Federal reimbursement received on account of eligible  
27 expenditures of the Department of County Operations.

28           (c) Other federal reimbursement funds received by the Department of  
29 County Operations shall be deposited into a separate federal reimbursement  
30 fund on the books of the Treasurer of State.

31           (d) The fund shall be used for maintenance, operations, and  
32 improvements required by the Department of County Operations in carrying out  
33 its powers, functions, and duties.

34  
35           SECTION 5. Arkansas Code § 20-77-1103 is amended to read as follows:  
36           20-77-1103. Definitions.

1 For purposes of this subchapter:

2 (1) "Family" means a family as defined in the Medical Services  
3 Policy Manual ~~of published by the Division~~ Department of County Operations ~~of~~  
4 ~~the Department of Human Services~~; and

5 (2) "Healthcare coverage" means healthcare insurance as defined  
6 by rules promulgated by the Department of Human Services for the ARKids First  
7 Program.

8  
9 SECTION 6. Arkansas Code § 25-10-102(a), concerning the organization  
10 of the Department of Human Services, is amended to read as follows:

11 (a) The Department of Human Services shall consist of and be operated  
12 under an integrated service system consisting of the following divisions with  
13 responsibilities and programs assigned to them as determined by the Director  
14 of the Department of Human Services:

15 (1) A The Division of Aging and Adult Services;

16 (2) A The Division of Medical Services;

17 (3) A The Division of Behavioral Health Services, which shall  
18 include community mental health centers and state hospitals;

19 (4) A The Division of Developmental Disabilities Services, which  
20 shall include both community programs and human development centers;

21 ~~(5) A Division of County Operations;~~

22 ~~(6)~~ A The Division of Administrative Services;

23 ~~(7)~~(6) A The Division of Youth Services, which shall include  
24 serious offender and community-based programs and the youth service centers;

25 ~~(8)~~(7) A The Division of Community Service and Nonprofit  
26 Support;

27 ~~(9)~~(8) A The Division of State Services for the Blind;

28 ~~(10)~~(9) A The Division of Children and Family Services; and

29 ~~(11)~~(10) A The Division of Child Care and Early Childhood  
30 Education.

31  
32 SECTION 7. Arkansas Code § 25-10-132 is amended to read as follows:

33 25-10-132. Medical services and county operations – Use of local  
34 funds.

35 To the extent allowed by federal requirements, including waiver,  
36 demonstration, and pilot project options, the Division of Medical Services of

1 the Department of Human Services and the ~~Division~~ Department of County  
2 Operations ~~of the Department of Human Services~~ shall use local and donated  
3 funds to obtain federal matching funds to enhance federal agency programs.  
4

5 SECTION 8. Arkansas Code § 25-11-103 is amended to read as follows to  
6 repeal obsolete language:

7 25-11-103. ~~Transfer of the Weatherization Assistance Program~~ Low-  
8 Income Home Energy Assistance Program – Annual transfer of percentage of  
9 allocation from Department of Human Services to Arkansas Economic Development  
10 Commission.

11 ~~(a)(1) The Weatherization Assistance Program, a federally funded~~  
12 ~~program under 42 U.S.C. § 6861 et seq., operated by the Division of County~~  
13 ~~Operations of the Department of Human Services is abolished and all the~~  
14 ~~powers, duties and functions, records, property, personnel, unexpended~~  
15 ~~balances of appropriations, allocations, or other funds are transferred by a~~  
16 ~~type 3 transfer to the Arkansas Energy Office of the Arkansas Economic~~  
17 ~~Development Commission.~~

18 ~~(2) This transfer does not conflict with any duties,~~  
19 ~~responsibilities, or powers of the office.~~

20 ~~(b) Unspent funds associated with the Weatherization Assistance~~  
21 ~~Program shall be transferred from the Department of Human Services to the~~  
22 ~~commission within thirty (30) days of the effective date of this act.~~

23 ~~(c) The department~~ Department of Human Services annually shall  
24 transfer to the ~~commission~~ Arkansas Economic Development Commission a minimum  
25 of fifteen percent (15%) up to a maximum of twenty-five percent (25%), as  
26 allowed by federal law or regulation, of the annual allocation for the ~~Low~~  
27 ~~Income~~ Low-Income Home Energy Assistance Program to the commission to be used  
28 by the ~~Low Income~~ Low-Income Home Energy Assistance Program.  
29

30 SECTION 9. Arkansas Code Title 25 is amended to add an additional  
31 chapter to read as follows:

32 Chapter 43 – Department of County Operations

33  
34 25-43-101. Purpose.

35 The purpose of this chapter is to establish the Department of County  
36 Operations.

25-43-102. Creation – Director.

(a) There is created the Department of County Operations.

(b) The executive head of the department shall be the Director of the Department of County Operations to be appointed by the Governor with consent of the Senate to serve at the pleasure of the Governor.

25-43-103. Duties and responsibilities.

(a) The Department of County Operations shall:

(1) Determine the eligibility of individuals applying for benefits in the Arkansas Medicaid Program, the Supplemental Nutrition Assistance Program under 7 U.S.C. § 2011 et seq., and the Transitional Employment Assistance Program under §§ 20-76-401 and 20-76-402;

(2) Redetermine the eligibility of individuals renewing benefits in the Arkansas Medicaid Program, the Supplemental Nutrition Assistance Program under 7 U.S.C. § 2011 et seq., and the Transitional Employment Assistance Program under §§ 20-76-401 and 20-76-402; and

(3) Fulfill other duties and responsibilities previously held by the Division of County Operations of the Department of Human Services, including without limitation rulemaking, licensing, promulgation of rules, rates, and standards, and the rendering of findings, orders, and adjudications.

(b) The Director of the Department of County Operations shall report quarterly to the Governor and the General Assembly regarding the results of the eligibility determinations.
