24	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

26	SECTION 1. Arkansas Code Title 17, Chapter 101, is amended to add an	
27	additional subchapter to read as follows:	
28		
29	<u>Subchapter 4 — Veterinary Advanced Technologist</u>	
30		
31	17-101-401. Definitions.	
32	As used in this subchapter:	
33	(1) "Large animal" means the same as defined in § 2-40-1301;	
34	(2) "Practice of veterinary medicine" means the same as defined	
35	in § 17-101-102:

1	(3) "Supervising veterinarian" means a veterinarian licensed by
2	the Veterinary Medical Examining Board who supervises a veterinary advanced
3	technologist;
4	(4)(A) "Supervision" means overseeing the activities of and
5	accepting responsibility for the veterinary services rendered by a veterinary
6	advanced technologist by a supervising veterinarian.
7	(B) "Supervision" does not mean the constant physical
8	presence of a veterinarian as long as the supervising veterinarian and the
9	veterinary advanced technologist are, or can be easily, in contact with one
10	another by radio, telephone, or other electronic or telecommunication device;
11	and
12	(5) "Veterinary advanced technologist" means a person who
13	performs the practice of veterinary medicine under the supervision of a
14	veterinarian licensed in this state.
15	
16	<u>17-101-402.</u> Qualifications for licensure — Application — Examination.
17	(a) A person seeking licensure as a veterinary advanced technologist
18	in this state shall submit a written application to the Veterinary Medical
19	Examining Board showing that he or she is:
20	(1) At least twenty-one (21) years of age; and
21	(2) A person of moral integrity and acceptable ethical
22	standards.
23	(b) The application for veterinary advanced technologist licensure
24	shall:
25	(1) Be completed and signed by the applicant;
26	(2) Document that the applicant shall provide services only for
27	large animals;
28	(3) Be submitted to the board at least thirty (30) days before
29	the date of the board's licensure examination;
30	(4) Be accompanied by a nonrefundable application fee
31	established by the board; and
32	(5) Include without limitation:
33	(A) A current photograph of the applicant;
34	(B) A certified transcript of the applicant's animal
35	science program records;

1	(C)(i) A written statement from a large animal veterinary
2	technician program accredited by the America Veterinary Medical Association
3	that certifies the applicant's qualification for graduation if he or she has
4	not graduated at the time of application.
5	(ii) However, a copy of the diploma shall be
6	submitted upon availability and before the examination date; and
7	(D) A written statement that certifies that the applicant
8	has completed a one-semester preceptorship or internship concerning the care
9	of large animals.
10	(c)(1) If the board finds that the applicant has the proper
11	qualifications, the board shall authorize him or her to take the examination.
12	(2) If an applicant is found to be unqualified to take the
13	examination, the board shall immediately notify the applicant in writing of
14	the board's findings and the grounds for denial.
15	(d)(1) The board shall conduct an examination of the applicants for
16	veterinary advanced technologist licensure.
17	(2) The examination shall include without limitation questions
18	testing the applicant's knowledge of:
19	(A) The Arkansas Veterinary Medical Practice Act, § 17-
20	<u>101-101 et seq.;</u>
21	(B) State and federal statutes relating to prescription
22	and controlled drugs;
23	(C) The ethics of veterinary medicine; and
24	(D) The rules of the Arkansas Livestock and Poultry
25	Commission, the United States Department of Agriculture, the Animal and Plant
26	Health Inspection Service, and Rabies Control.
27	
28	<u>17-101-403. Scope of practice – Prescriptive authority.</u>
29	<u>A veterinary advanced technologist may:</u>
30	(1) Perform those duties and responsibilities, including
31	prescribing medication and performing diagnosis, treatment, and surgery, as
32	delegated by his or her supervising veterinarian;
33	(2) Practice veterinary medicine in any setting authorized by
34	the supervising veterinarian; and
35	(3)(A) Prescribe, order, and administer:

1	(i) Schedule III — V controlled substances as
2	described in the Uniform Controlled Substances Act, §§ 5-64-101 et seq., and
3	<u>21 C.F.R. Part 1300;</u>
4	(ii) Hydrocodone combination products reclassified
5	from Schedule III to Schedule II as of October 6, 2014, if authorized by the
6	veterinary advanced technologist's supervising veterinarian;
7	(iii) All legend drugs; and
8	(iv) All nonschedule prescription medications and
9	medical devices.
10	(B) All prescriptions and orders issued by a veterinary
11	advanced technologist shall identify his or her supervising veterinarian.
12	(C) A veterinary advanced technologist who prescribes
13	controlled substances shall register with the United States Drug Enforcement
14	Administration as part of the United States Drug Enforcement Administration's
15	Mid-Level Practitioner Registry, 21 C.F.R. Part 1300, 58 FR 31171-31175, and
16	the Controlled Substances Act.
17	
18	<u>17-101-404. Supervision.</u>
19	(a) Supervision of a veterinary advanced technologist shall be
20	continuous but does not require the physical presence of the supervising
21	veterinarian at the time and place that the services are rendered.
22	(b) It is the obligation of each supervising veterinarian and each
23	veterinary advanced technologist to ensure that:
24	(1) The veterinary advanced technologist's scope of practice is
25	identified;
26	(2) The delegation of veterinary medical services is appropriate
27	to the veterinary advanced technologist's level of competence;
28	(3) The relationship and access to the supervising veterinarian
29	is defined; and
30	(4) A process of evaluation of the veterinary advanced
31	technologist's performance is established.
32	(c) The veterinary advanced technologist and supervising veterinarian
33	may designate back-up veterinarians who have agreed to supervise the
34	veterinary advanced technologist if the supervising veterinarian is absent.

1	(d) A veterinary advanced technologist may supervise or control a
2	separate office or clinic in a location other than the supervising
3	veterinarian's regular office if the supervision requirements are met.
4	(e) A veterinarian desiring to supervise a veterinary advanced
5	technologist shall:
6	(1) Be licensed in this state;
7	(2) Notify the Veterinary Medical Examining Board of his or her
8	intent to supervise a veterinary advanced technologist; and
9	(3) Submit a statement to the board that he or she will
10	supervise the veterinary advanced technologist in accordance with rules
11	adopted by the board.
12	
13	17-101-405. Disciplinary authority.
14	<u>Upon finding that a veterinary advanced technologist or an applicant</u>
15	has committed an offense described in § 17-101-305, the Veterinary Medical
16	Examining Board may:
17	(1) Refuse to grant a license;
18	(2) Administer a public or private reprimand;
19	(3) Revoke, suspend, limit, or otherwise restrict a license;
20	(4) Require a veterinary advanced technologist to submit to the
21	care, counseling, or treatment of a physician or psychologist designated by
22	the board;
23	(5) Suspend enforcement of a penalty and place the veterinary
24	advanced technologist on probation;
25	(6) Revoke the probation of a veterinary advanced technologist
26	for noncompliance with the probation; or
27	(7) Restore or reissue, at the board's discretion, a license and
28	impose any disciplinary or corrective measure which the board deem
29	appropriate.
30	
31	17-101-406. Rulemaking authority.
32	The Veterinary Medical Examining Board shall:
33	(1) Promulgate rules in accordance with the Arkansas
34	Administrative Procedure Act, § 25-15-201 et seq., that are reasonable and
35	necessary for the performance of the duties imposed upon the board by this
36	subchapter; and

1	(2) Administer the provisions of this subchapter under
2	procedures the board considers advisable and adopt rules that are reasonable
3	and necessary to implement the provisions of this subchapter.
4	
5	17-101-407. Title and practice protection.
6	(a) A person who is not licensed under this subchapter is guilty of a
7	Class A misdemeanor and is subject to penalties applicable to the unlicensed
8	practice of veterinary medicine if he or she:
9	(1) Holds himself or herself out as a veterinary advanced
10	technologist;
11	(2) Uses any combination or abbreviation of the term "veterinary
12	advanced technologist" to indicate or imply that he or she is a veterinary
13	advanced technologist; or
14	(3) Acts as a veterinary advanced technologist.
15	(b) An unlicensed veterinarian shall not be permitted to use the title
16	of veterinary advanced technologist or to practice as a veterinary advanced
17	technologist unless he or she fulfills the requirements of this subchapter.
