26	SECTION 1. Arkansas Code Title 17, Chapter 87, Subchapte	r 3, is
27	amended to add an additional section to read as follows:	
28	17-87-313. Full independent practice authority.	
29	(a) As used in this section, "full independent practice	authority"
30	means the ability of an advanced practice registered nurse to p	ractice with
31	prescriptive authority without a collaborative practice agreeme	<u>nt as</u>
32	described under § 17-87-310.	
33	(b) The Arkansas State Medical Board shall grant a certi	ficate of full
34	independent practice to an advanced practice registered nurse w	<u>ho submits:</u>
35	(1) An application with an application fee as dete	rmined by the
36	board;	

1	(2) Proof of successful completion of ten thousand four hundred
2	(10,400) hours of practice under the supervision of a physician; and
3	(3) Any other relevant information determined by the board.
4	(c)(l) An advanced practice registered nurse with a certificate of
5	full independent practice may receive and prescribe drugs, medicines, or
6	therapeutic drugs appropriate to the advanced practice registered nurse's
7	area of practice.
8	(2) The full independent practice authority shall extend to
9	drugs listed in Schedules II - V.
10	(d) The board may:
11	(1) Adopt rules regarding the full independent practice
12	authority; and
13	(2) Discipline an advanced practice registered nurse for
14	violations of:
15	(A) This chapter;
16	(B) Applicable sections of the Arkansas Medical Practices
17	Act, § 17-95-201 et seq., § 17-95-301 et seq., and § 17-95-401 et seq.; or
18	(C) Rules adopted under this section.
