21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23	SECTION 1. Arkansas Code Title 20, Chapter 77, Subchapter 1, is
24	amended to add an additional section to read as follows:
25	20-77-135. Prohibition of cost-settlement reimbursement.
26	(a) As used in this section, "cost-settlement reimbursement" means
27	reimbursement of reasonable costs that are actually incurred by a healthcare
28	provider within a child health management services program or any successor
29	program providing early intervention day treatment services to children or
30	the rehabilitative services for persons with mental illness program or any
31	<u>successor program providing adult developmental day treatment services in</u>
32	order to provide a healthcare service to the extent that the costs are
33	necessary to efficiently deliver that service and the costs are in excess of
34	the reimbursement for the healthcare service.
35	(b) The Arkansas Medicaid Program is prohibited from providing cost-
36	settlement reimbursement to the University of Arkansas for Medical Sciences.
