27	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

29	SECTION 1. Arkansas Code § 6-21-808(c)(2)(A), regarding the required							
30	contents of a preventative maintenance plan, is amended to read as follows:							
31	(A) The required contents of a preventive maintenance							
32	plan, which shall include guidelines for:							
33	(i) Scheduling preventive maintenance activities for							
34	public school facilities and athletic equipment;

1	(ii) Preparing and retaining documentation that
2	describes preventive maintenance work related to public school facilities and
3	athletic equipment and identifies the completion date of the work;
4	(iii) Scheduling lawfully required inspections of
5	public school facilities and athletic equipment conducted by state agencies
6	and commissions; and
7	(iv) Scheduling the inspections specified by the
8	Commission for Arkansas Public School Academic Facilities and Transportation
9	relating to safe, dry, and healthy public school facilities;

11	SECTION 2. Arkansas Code § 6-21-808(c)(2)(D), concerning training
12	criteria for maintenance personnel, is amended to read as follows:
13	(D) Training criteria for maintenance personnel with
14	regard to:
15	(i) School policies;
16	(ii) Safety procedures;
17	(iii) Use of specialized equipment;
18	(iv) Compliance with federal, state, county, and
19	municipal laws and regulations impacting public school facilities and
20	equipment; and
21	(v) Inspection of athletic equipment; and
22	(v)(vi) Other applicable areas;

24	SECTION 3. Arkansas Code § 6-21-808(c)(2)(J) and (K), regarding the
25	required contents of a preventative maintenance plan, are amended to read as
26	follows:
27	(J) Inspection of playground equipment; and
28	(K) Grounds maintenance <del>.; and</del>
29	(L)(i) Inspection of athletic equipment.
30	(ii) A public school district shall contract with a
31	company to train maintenance personnel to conduct an inspection of athletic
32	equipment under this subdivision (c)(2)(L).
33	(iii) A public school district shall conduct an
34	inspection of athletic equipment at least one (1) time each month.
