25	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

27	SECTION 1. Arkansas Code Title 16, Chapter 10, Subchapter 1, is	
28	amended to add an additional section to read as follows:	
29	16-10-141. Prohibition against suspension of driver's license.	
30	(a) Unless the requirements of subsection (b) of this section are met:	
31	(1) A circuit court or a district court shall not suspend a	
32	person's driver's license solely because the person has failed to pay a fine	
33	or fee as ordered by the circuit court or district court; and	
34	(2) A district court shall not suspend a person's driver's	
35	license solely because the person has failed to appear as required by the	
36	district court.	

.

1	(b) If a person has failed to pay a fine or fee assessed by a circuit
2	court or district court or has failed to appear in district court, the
3	circuit court or district court, as applicable, may suspend the person's
4	driver's license if the circuit court or district court:
5	(1) Orders the suspension to begin within fifteen (15) days of
6	the date of the order if the person fails to make arrangements to pay the
7	fine or fee or appear in circuit court or district court, whichever is
8	applicable; and
9	(2) Transmits a copy of the order electronically, by fax, or by
10	letter to the appropriate division of the Department of Finance and
11	Administration.
12	(c) The department shall notify the person by first class mail sent to
13	the person's last known address that he or she risks having his or her
14	driver's license suspended if the person does not make arrangements with the
15	circuit court or district court to appear in circuit court or district court
16	or make arrangements to pay the fine or fee, whichever is applicable, within
17	fifteen (15) days of the date of the order suspending the driver's license.
18	(d)(l) If the person makes sufficient arrangements with the circuit
19	court or district court to pay the fine or fee or appear in circuit court or
20	district court, whichever is applicable, the circuit court or district court
21	shall issue a new order stating that the person's license is no longer
22	suspended as directed under subsection (b) of this section.
23	(2) The circuit court or district court shall transmit a copy of
24	the order rescinding the suspension of the person's driver's license to the
25	department electronically, by fax, or by letter.

27	SECTION 2. Arkansas Code § 16-13-708 is amended to read as follows:
28	16-13-708. Revocation of registration or license.
29	(a) The If the court has complied with the requirements of § 16-10-
30	<u>141(b), the court</u> may certify in writing to the Department of Finance and
31	Administration that a debtor has failed to make satisfactory arrangements for
32	the payment of fines and request the department to revoke, suspend, or refuse
33	to renew the debtor's motor vehicle registration or driver's license.
34	(b) For driver's license revocation, the court <del>must</del> shall provide the
35	department with the debtor's full name, social security Social Security
36	number, and last known address.

                 (3) After the person satisfies all requirements of the sentence,
