21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22	
23	SECTION 1. Arkansas Code § 5-71-101, concerning definitions, is
24	amended to add a new definition to read as follows:
25	(13) "Civil disobedience" means an act or omission committed by
26	a person in furtherance of:
27	(A) The exercise of his or her rights under the United
28	States Constitution, the Arkansas Constitution, or clearly established
29	<u>federal or state law;</u>
30	(B) A peaceful political or nonpolitical protest; or
31	(C) The refusal to comply with laws or local ordinances as
32	<u>a peaceful form of political protest.</u>
33	
34	SECTION 2. Arkansas Code Title 5, Chapter 71, Subchapter 2, is amended
35	to add an additional section to read as follows:

1	5-71-219. Civil disobedience offenses — Excessive bail or appearance
2	bond prohibited.
3	(a) Bail or an appearance bond shall not be more than fifty dollars
4	(\$50.00) if a person arrested for committing one (1) or more of the following
5	offenses is at the time of his or her arrest engaging in an act of civil
6	disobedience:
7	(1) Unlawful assembly, § 5-71-205;
8	(2) Failure to disperse, § 5-71-206;
9	<pre>(3) Disorderly conduct, § 5-71-207;</pre>
10	(4) Obstructing a highway or other public passage, § 5-71-214;
11	<u>or</u>
12	(5) Any offense or violation established by local ordinance that
13	prohibits an act or omission listed under subdivisions (a)(l)-(4) of this
14	section.
15	(b) Bail or an appearance bond under this section is not required in
16	lieu of the issuance of a citation or a release on the person's recognizance
17	if the person at the time of his or her arrest:
18	(1) Did not pose a threat to the community; and
19	(2) Did not deface or destroy public or private property.
