15	TO AMEND THE LAW CONCERNING PREPAID
16	WIRELESS PUBLIC SAFETY CHARGES.

19	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20	
21	SECTION 1. Arkansas Code § 12-10-326(b)(1), concerning prepaid
22	wireless public safety charges, is amended to read as follows:
23	(b)(l) For each retail transaction occurring in this state, a seller
24	of prepaid wireless services <u>service</u> shall collect from the consumer a public
25	safety charge equal to ten :
26	(A) Ten percent (10%) of the value of the prepaid wireless
27	service <u>through December 31, 2022;</u>
28	(B) Seven and five-tenths percent (7.5%) of the value of
29	the prepaid wireless service beginning January 1, 2023; and
30	(C) Five percent (5%) of the value of the prepaid wireless
31	service beginning January 1, 2024.
32	
33	SECTION 2. Arkansas Code § 19-5-1152(e), concerning the Arkansas
34	Public Safety Trust Fund, is amended to read as follows:

1	(e)(1) On or before the fifteenth business day of July 2020 and on the
2	fifteenth business day of each fiscal quarter thereafter, moneys in the fund
3	shall be distributed as follows:
4	(1) (A) Up to sixty-two thousand five hundred dollars (\$62,500)
5	to the Arkansas Commission on Law Enforcement Standards and Training; and
6	(2) (B) Up to two million dollars (\$2,000,000) to the division to
7	support upgrades and maintenance for the Arkansas Wireless Information
8	Network.
9	(2) The entities under subdivision (e)(1) of this section are
10	subject to the decreased amount of collection under § 12-10-326(b)(1) on an
11	equal basis.
