22	TO AUTHORIZE THE ARKANSAS STATE GAME AND
23	FISH COMMISSION TO PROMULGATE RULES
24	ALLOWING A ONE-TIME FEE ADJUSTMENT TO
25	HUNTING AND FISHING LICENSES FOR
26	RESIDENTS BASED ON CERTAIN CRITERIA; AND
27	TO REQUIRE REPORTING BY THE COMMISSION.

30	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
31	
32	SECTION 1. Arkansas Code § 15-42-104(e), concerning special fees for
33	hunting and fishing licenses for residents, is amended to read as follows:
34	(e) For this section, the commission may promulgate rules that:
35	(1) Define "resident" and "totally disabled"; and

1	(2) Govern the sale and use of each license, permit, or stamp
2	issued under this section . ; and
3	(3)(A) Allow a one-time adjustment for an increase or decrease
4	in the amount of the maximum fee, also known as the baseline maximum, for
5	each resident license, permit, or stamp set forth in subsections (a) through
6	(d) of this section so long as the total fee for each license, permit, or
7	stamp after the adjustment does not exceed:
8	(i) Two (2) times the baseline maximum; or
9	(ii) The sum of the baseline maximum and its
10	proportional fee adjustment based upon the total increase in the Consumer
11	Price Index for All Urban Consumers issued by the United States Bureau of
12	Labor Statistics since the baseline maximum was established or last adjusted.
13	(B) The commission shall provide a report to the Game and
14	Fish/State Police Subcommittee of the Legislative Council for administrative
15	review of the fee adjustment under subdivision (e)(3)(A) of this section.
16	
17	SECTION 2. Arkansas Code § 15-42-104, concerning hunting and fishing
18	licenses for residents, is amended to add an additional subsection to read as
19	follows:
20	(f) The commission shall provide a quarterly report to the
21	subcommittee of the Legislative Council regarding commission activities
22	related to hunting and fishing licenses for residents.
