## 11 For An Act To Be Entitled

12 AN ACT TO ESTABLISH A RIGHT OF PRIVACY CONCERNING  
13 CORONAVIRUS 2019 (COVID-19) VACCINATION STATUS; TO  
14 ESTABLISH A GRANT PROGRAM WITH DISTRIBUTION FROM  
15 COVID-19 RELIEF FUNDS TO PROVIDE RESTITUTION FOR  
16 INDIVIDUALS; TO DECLARE AN EMERGENCY; AND FOR OTHER  
17 PURPOSES.

21 TO ESTABLISH A RIGHT OF PRIVACY  
22 CONCERNING CORONAVIRUS 2019 (COVID-19)  
23 VACCINATION STATUS; TO ESTABLISH A GRANT  
24 PROGRAM WITH DISTRIBUTION FROM COVID-19  
25 RELIEF FUNDS; AND TO DECLARE AN  
26 EMERGENCY.

29 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

30  
31 SECTION 1. Arkansas Code Title 11, Chapter 3, Subchapter 1, is amended  
32 to add an additional section to read as follows:

33 11-3-102. Right of privacy concerning vaccination status.

34 (a)(1) An individual has the right to decide whether he or she  
35 discloses his or her vaccination status for coronavirus 2019 (COVID-19),

1 severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2), or any of its  
2 mutations, in an employment setting.

3 (2) The right to decide whether to disclose his or her  
4 vaccination status under subdivision (a)(1) of this section is available to:

5 (A) Employees of an employer;

6 (B) Individuals seeking employment with an employer; and

7 (C) Individuals engaging in contracts with an employer.

8 (b) An employer is prohibited from:

9 (1) Requiring the disclosure of an individual's vaccination  
10 status for coronavirus 2019 (COVID-19), severe acute respiratory syndrome  
11 coronavirus 2 (SARS-CoV-2), or any of its mutations; and

12 (2) Retaliating against an individual for exercising his or her  
13 right of privacy under subsection (a) of this section.

14 (c) An employee or individual who is injured by an employer in  
15 violation of this section shall have the remedies and procedures available  
16 under the Arkansas Civil Rights Act of 1993, § 16-123-101 et seq.

17 (d)(1) The Department of Finance and Administration may establish a  
18 grant program with distribution of COVID-19 relief funds to provide  
19 restitution to individuals injured by a violation of this section.

20 (2) The department may promulgate rules to administer the grant  
21 program and for the distribution of COVID-19 relief funds under the program.

22  
23 SECTION 2. EMERGENCY CLAUSE. It is found and determined by the  
24 General Assembly of the State of Arkansas that employers are requiring  
25 individuals to obtain vaccination against coronavirus 2019 (COVID-19), severe  
26 acute respiratory syndrome coronavirus 2 (SARS-CoV-2), or any of its  
27 mutations, which is creating a situation in which an individual could be  
28 discriminated against; that protecting individuals from discrimination is  
29 vital to ensuring equality; and that this act is immediately necessary to  
30 ensure the equality of all Arkansans. Therefore, an emergency is declared to  
31 exist, and this act being immediately necessary for the preservation of the  
32 public peace, health, and safety shall become effective on:

33 (1) The date of its approval by the Governor;

34 (2) If the bill is neither approved nor vetoed by the Governor,  
35 the expiration of the period of time during which the Governor may veto the  
36 bill; or

1                   (3) If the bill is vetoed by the Governor and the veto is  
2 overridden, the date the last house overrides the veto.
