18	TO SPECIFY CERTAIN OWNERSHIP REQUIREMENTS
19	IN ORDER TO OBTAIN A PHARMACY PERMIT.

22	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23	
24	SECTION 1. Arkansas Code Title 17, Chapter 92, Subchapter 4, is
25	amended to add an additional section to read as follows:
26	17-92-413. Pharmacy permit ownership requirements.
27	(a) In order to be issued a pharmacy permit under § 17-92-405, a
28	pharmacy shall submit to the Arkansas State Board of Pharmacy proof that the
29	applicant for the pharmacy permit is qualified to conduct the pharmacy and
30	<u>is:</u>
31	(1) A pharmacist licensed by the board and in good standing;
32	(2) A partnership in which each active member is a pharmacist
33	licensed by the board and in good standing;
34	(3) A corporation or association in which the majority stock is
35	owned by pharmacists licensed by the board and in good standing; or

1	(4) A limited liability company in which the majority membership
2	interests are owned by pharmacists licensed by the board and in good
3	standing, actively and regularly employed in and responsible for the
4	management, supervision, and operation of the pharmacy.
5	(b) This section does not apply to:
6	(1) A pharmacy with a pharmacy permit on or before the effective
7	date of this act;
8	(2) A pharmacy chain that is headquartered in this state; or
9	(3) A pharmacy that is within an institution such as a hospital.
