22	SECTION 1. Arkansas Code § 26-52-401, concerning sales tax exemptions	3
23	for certain products and services, is amended to add an additional	
24	subdivision to read as follows:	
25	(43)(A) Gross receipts or gross proceeds derived from the sale	
26	of feminine hygiene products.	
27	(B) "Feminine hygiene products" means tampons, panty	
28	liners, menstrual cups, sanitary napkins, and other similar tangible persona	11
29	property designed for feminine hygiene in connection with the human menstrua	11
30	cycle, but does not include grooming and hygiene products;	
31	(8) "Grooming and hygiene products" means soaps and cleaning	
32	solutions, shampoo, toothpaste, mouthwash, antiperspirants, and sun tan	
33	lotions and screen, regardless of whether the items meet the definition of	
34	"over-the-counter drug";

1	(9) "Over-the-counter drug" means a drug that contains a label
2	that identifies the product as a drug as required by 21 C.F.R. § 201.66, as
3	it existed on January 1, 2022;

5	SECTION 2. EFFECTIVE DATE. Section 1 of this act is effective on the
6	first day of the calendar quarter following the effective date of this act.
