1	(1) The person knowingly causes the death of another person
2	under circumstances manifesting extreme indifference to the value of human
3	life; or
4	(2) With the purpose of causing serious physical injury to
5	another person, the person causes the death of any person .; or
6	(3) Under circumstances manifesting extreme indifference to the
7	value of human life, he or she recklessly causes the death of another person
8	as a result of operating a motor vehicle, an aircraft, or a motorboat:
9	(A) While intoxicated; or
10	(B)(i) If at that time, there is an alcohol concentration
11	of eight hundredths (0.08) or more in the person's breath or blood, based
12	upon the definition of alcohol concentration in § 5-65-204, as determined by
13	a chemical test of the person's blood, urine, breath, saliva, or other bodily
14	substance.
15	(ii) The method of the chemical test of the person's
16	blood, urine, saliva, breath, or other bodily substance shall be made in
17	accordance with §§ 5-65-204 and 5-65-206.
18	(b) As used in this section:
19	(1) "Aircraft" means the same as defined in § 5-75-101;
20	(2) "Intoxicated" means the same as defined in § 5-65-102;
21	(3) "Motorboat" means the same as defined in § 5-65-102; and
22	(4) "Motor vehicle" means the same as defined in § 5-65-102.
23	(c) Murder in the second degree is a Class A felony.
