1	SECTION 3. Arkansas Code Title 25, Chapter 43, Subchapter 2, is
2	amended to add an additional section to read as follows:
3	25-43-203. Water and Sewer Treatment Facilities Grant Program.
4	(a)(1) There is created within the Arkansas Natural Resources
5	Commission the Water and Sewer Treatment Facilities Grant Program to be
6	administered by the commission.
7	(2) The commission may hire personnel necessary to carry out the
8	duties of administering the program.
9	(b) The commission shall:
10	(1) Create an application form to be submitted by eligible water
11	and sewer treatment facilities seeking a matching grant from the program;
12	(2) Devise an application process that:
13	(A) Defines the eligibility criteria for a matching grant;
14	<u>and</u>
15	(B) Establishes application submittal and review
16	processes;
17	(3) Define a process by which matching grants may be awarded;
18	(4) Execute standard legal grant agreements and other
19	documentation governing the disbursement and use of matching grants; and
20	(5) Provide matching grants to eligible water and sewer
21	treatment facilities for infrastructure and improvement projects that are
22	shovel ready.
23	(c) The commission shall promulgate rules necessary for the
24	implementation of the program.
25	
26	SECTION 4. EMERGENCY CLAUSE. It is found and determined by the
27	General Assembly of the State of Arkansas that it is in the best interest of
28	the citizens of this state to provide water and sewer grant opportunities for
29	projects to keep Arkansas water systems safe and clean; and that this act is
30	necessary because there is a dire need to protect public health and safety in
31	Arkansas by replacing water and sewer lines in disrepair and providing new
32	access to clean water systems to other citizens. Therefore, an emergency is
33	declared to exist, and this act being immediately necessary for the
34	preservation of the public peace, health, and safety shall become effective
35	on:
36	(1) The date of its approval by the Governor;

T	(2) If the bill is heither approved nor veloed by the Governor,
2	the expiration of the period of time during which the Governor may veto the
3	bill; or
4	(3) If the bill is vetoed by the Governor and the veto is
5	overridden, the date the last house overrides the veto.
