17	Subtitle
18	TO CREATE AND ISSUE A DRIVER'S LICENSE
19	WITH A FIREARM DESIGNATION; AND TO AMEND
20	THE LAW CONCERNING THE FEES FOR THE
21	ISSUANCE OF A DRIVER'S LICENSE.
22	
23	
24	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25	
26	SECTION 1. DO NOT CODIFY. Legislative findings.
27	The General Assembly finds that the people of Arkansas have certain
28	inalienable rights that are protected and guaranteed by the United States
29	Constitution and the Arkansas Constitution, and among those rights is the
30	right to keep and bear arms for their defense of persons, property, and
31	against tyrannical encroachment.
32	
33	SECTION 2. Arkansas Code § 27-16-701, concerning the application for a
34	driver's license, instruction permit, and restricted permit, is amended to
35	add an additional subsection to read as follows:

1	(g)(1) Every application for a driver's license or renewal by a person
2	eighteen (18) or more years of age shall be accompanied by an instant federal
3	criminal background check as provided in § 27-16-817.
4	(2) The instant federal criminal background check shall be
5	conducted as established by § 27-16-817 at no additional cost to the
6	applicant.
7	(3) The Office of Driver Services shall provide a form giving a
8	person the option to opt out of the instant federal criminal background check
9	requirement under subdivision (g)(1) of this section.
10	
11	SECTION 3. Arkansas Code § 27-16-801(a)(1), concerning the issuance of
12	licenses generally, is amended to read as follows:
13	(a)(l)(A) In a manner prescribed by the Secretary of the Department of
14	Finance and Administration, the Office of Driver Services shall issue:
15	(i) Except as provided in subdivision <u>subdivisions</u>
16	(a)(l)(B) and (a)(l)(C) of this section, a Class D license or a Class M
17	license to each qualified applicant eighteen (18) or more years of age, for a
18	period of eight (8) years, upon payment of twenty-four dollars (\$24.00)
19	twenty-six dollars (\$26.00);
20	(ii) An intermediate Class D license or an
21	intermediate Class M license to each applicant between sixteen (16) and
22	eighteen (18) years of age, for a period of up to two (2) years, upon payment
23	of twelve dollars (\$12.00) fourteen dollars (\$14.00);
24	(iii) A learner's Class D license to each applicant
25	between fourteen (14) and sixteen (16) years of age, for a period of up to
26	two (2) years, upon payment of twelve dollars (\$12.00) <u>fourteen dollars</u>
27	<u>(\$14.00);</u> and
28	(iv) A Class MD license to each qualified applicant,
29	for a period of not more than two (2) years, upon payment of $\frac{1}{1}$
30	(\$2.00) <u>four dollars (\$4.00)</u> .
31	(B) A Except as provided in subdivision $(a)(1)(C)$ of this
32	section, a Class D license or a Class M license shall be issued for a period
33	to be elected by the applicant of either four (4) years upon payment of
34	twelve dollars (\$12.00) <u>fourteen dollars (\$14.00)</u> or eight (8) years upon
35	payment of twenty-four dollars (\$24.00) <u>twenty-six dollars (\$26.00)</u> to a
36	qualified applicant who:

1	(i) Is seventy (70) or more years of age; and
2	(ii) Has an expired Class D license or Class M
3	license.
4	(C) A Class D license or a Class M license with a firearm
5	designation under § 27-16-817 shall be issued for a period of five (5) years
6	upon payment of twenty-six dollars (\$26.00).
7	
8	SECTION 4. Arkansas Code Title 27, Chapter 16, Subchapter 8, is
9	amended to add an additional section to read as follows:
10	27-16-817. Federal criminal background check and firearm designation.
11	(a)(1) The Department of Finance and Administration and the
12	Identification Bureau of the Division of Arkansas State Police shall
13	coordinate to establish a system to provide the Office of Driver Services
14	with an instant federal criminal background check from the Federal Bureau of
15	Investigation that satisfies the federal criminal background check
16	requirements for the purchase of a firearm.
17	(2) The Office of Driver Services shall require that:
18	(A) An applicant sign a release of information; and
19	(B) The information received from an instant federal
20	criminal background check:
21	(i) Shall be used only for the purpose of making
22	decisions regarding the issuance of a driver's license with a firearm
23	designation under this section; and
24	(ii) Is confidential and shall not be released to
25	any third party.
26	(b)(1) The Identification Bureau of the Division of Arkansas State
27	Police shall provide the Office of Driver Services with the instant federal
28	criminal background check required under this section within the time it
29	takes for an person to apply for and be issued a driver's license at a local
30	revenue office.
31	(2) A driver's license with a firearm designation under
32	subsection (c) of this section shall not be issued until the Office of Driver
33	Services receives the instant federal criminal background check and verifies
34	that the information available does not indicate that the possession of a
35	firearm by the applicant would be in violation of Arkansas law or federal
36	law.

1	(c)(l) If an instant federal criminal background check is approved,
2	the Office of Driver Services shall issue a driver's license with a firearm
3	designation.
4	(2) A driver's license with a firearm designation shall be valid
5	for five (5) years and an instant federal criminal background check shall be
6	required upon renewal.
7	(d) The Department of Finance and Administration and the Division of
8	the Arkansas State Police shall promulgate rules necessary for the
9	implementation of this section, including without limitation:
10	(1) A policy concerning the retention of the information
11	obtained from the instant federal criminal background check;
12	(2) The criteria for revoking and reissuing a driver's license
13	with a firearm designation issued under this section; and
14	(3) Any rules necessary for a driver's license with a firearm
15	designation under this section to qualify as an alternative to the background
16	check requirements of the Brady Handgun Violence Prevention Act, 18 U.S.C.§
17	922(t)(3), as it existed on January 1, 2023.
