32	Section 1. Purpose

- l license and discipline PAs and seeks to enhance the portability of a License
- 2 to practice as a PA while safeguarding the safety of patients. This Compact
- 3 <u>allows Medical Services to be provided by PAs, via the mutual recognition of</u>
- 4 the Licensee's Qualifying License by other Compact Participating States. This
- 5 Compact also adopts the prevailing standard for PA licensure and affirms that
- 6 the practice and delivery of Medical Services by the PA occurs where the
- 7 patient is located at the time of the patient encounter, and therefore
- 8 requires the PA to be under the jurisdiction of the State Licensing Board
- 9 where the patient is located. State Licensing Boards that participate in this
- 10 Compact retain the jurisdiction to impose Adverse Action against a Compact
- 11 Privilege in that State issued to a PA through the procedures of this
- 12 <u>Compact. The PA Licensure Compact will alleviate burdens for military</u>
- 13 <u>families by allowing active duty military personnel and their spouses to</u>
- 14 <u>obtain a Compact Privilege based on having an unrestricted License in good</u>
- 15 <u>standing from a Participating State.</u>
- 17 Section 2. Definitions
- 18 In this Compact:
- 19 A. "Adverse Action" means any administrative, civil, equitable, or
- 20 criminal action permitted by a State's laws which is imposed by a Licensing
- 21 Board or other authority against a PA License or License application or
- 22 Compact Privilege such as License denial, censure, revocation, suspension,
- 23 probation, monitoring of the Licensee, or restriction on the Licensee's
- 24 practice.

- 25 <u>B. "Compact Privilege" means the authorization granted by a Remote</u>
- 26 State to allow a Licensee from another Participating State to practice as a
- 27 PA to provide Medical Services and other licensed activity to a patient
- 28 located in the Remote State under the Remote State's laws and regulations.
- 29 C. "Conviction" means a finding by a court that an individual is
- 30 guilty of a felony or misdemeanor offense through adjudication or entry of a
- 31 plea of guilt or no contest to the charge by the offender.
- 32 D. "Criminal Background Check" means the submission of fingerprints or
- 33 other biometric-based information for a License applicant for the purpose of
- 34 obtaining that applicant's criminal history record information, as defined in
- 35 28 C.F.R. § 20.3(d), from the State's criminal history record repository as
- 36 <u>defined in 28 C.F.R. § 20.3(f).</u>

- 1 E. "Data System" means the repository of information about Licensees,
- 2 <u>including but not limited to License status and Adverse Actions, which is</u>
- 3 created and administered under the terms of this Compact.
- F. "Executive Committee" means a group of directors and ex-officio
- 5 individuals elected or appointed pursuant to Section 7.F.2.
- 6 G. "Impaired Practitioner" means a PA whose practice is adversely
- 7 affected by health-related condition(s) that impact their ability to
- 8 practice.
- 9 H. "Investigative Information" means information, records, or
- 10 documents received or generated by a Licensing Board pursuant to an
- ll investigation.
- 12 <u>I. "Jurisprudence Requirement" means the assessment of an individual's</u>
- 13 <u>knowledge of the laws and Rules governing the practice of a PA in a State.</u>
- J. "License" means current authorization by a State, other than
- 15 <u>authorization pursuant to a Compact Privilege, for a PA to provide Medical</u>
- 16 Services, which would be unlawful without current authorization.
- 17 K. "Licensee" means an individual who holds a License from a State to
- 18 provide Medical Services as a PA.
- 19 <u>L. "Licensing Board" means any State entity authorized to license and</u>
- 20 otherwise regulate PAs.
- 21 M. "Medical Services" means health care services provided for the
- 22 diagnosis, prevention, treatment, cure or relief of a health condition,
- 23 injury, or disease, as defined by a State's laws and regulations.
- N. "Model Compact" means the model for the PA Licensure Compact on
- 25 <u>file with The Council of State Governments or other entity as designated by</u>
- the Commission.
- 27 O. "Participating State" means a State that has enacted this Compact.
- 28 P. "PA" means an individual who is licensed as a physician assistant
- 29 <u>in a State. For purposes of this Compact, any other title or status adopted</u>
- 30 by a State to replace the term "physician assistant" shall be deemed
- 31 synonymous with "physician assistant" and shall confer the same rights and
- 32 <u>responsibilities to the Licensee under the provisions of this Compact at the</u>
- 33 time of its enactment.
- 34 Q. "PA Licensure Compact Commission," "Compact Commission," or
- 35 "Commission" mean the national administrative body created pursuant to
- 36 <u>Section 7.A of this Compact.</u>

1	R. "Qualifying License" means an unrestricted License issued by a
2	Participating State to provide Medical Services as a PA.
3	S. "Remote State" means a Participating State where a Licensee who is
4	not licensed as a PA is exercising or seeking to exercise the Compact
5	Privilege.
6	T. "Rule" means a regulation promulgated by an entity that has the
7	force and effect of law.
8	U. "Significant Investigative Information" means Investigative
9	Information that a Licensing Board, after an inquiry or investigation that
10	includes notification and an opportunity for the PA to respond if required by
11	State law, has reason to believe is not groundless and, if proven true, would
12	indicate more than a minor infraction.
13	V. "State" means any state, commonwealth, district, or territory of
14	the United States.
15	
16	Section 3. State Participation in this Compact
17	A. To participate in this Compact, a Participating State shall:
18	1. License PAs.
19	2. Participate in the Compact Commission's Data System.
20	3. Have a mechanism in place for receiving and investigating
21	complaints against Licensees and License applicants.
22	4. Notify the Commission, in compliance with the terms of this
23	Compact and Commission Rules, of any Adverse Action against a Licensee or
24	License applicant and the existence of Significant Investigative Information
25	regarding a Licensee or License applicant.
26	5. Fully implement a Criminal Background Check requirement,
27	within a time frame established by Commission Rule, by its Licensing Board
28	receiving the results of a Criminal Background Check and reporting to the
29	Commission whether the License applicant has been granted a License.
30	6. Comply with the Rules of the Compact Commission.
31	7. Utilize passage of a recognized national exam such as the

License in a Participating State.

B. Nothing in this Compact prohibits a Participating State from charging a fee for granting the Compact Privilege.

2	Section 4. Compact Privilege
3	A. To exercise the Compact Privilege, a Licensee must:
4	1. Have graduated from a PA program accredited by the
5	Accreditation Review Commission on Education for the Physician Assistant,
6	Inc. or other programs authorized by Commission Rule.
7	2. Hold current NCCPA certification.
8	3. Have no felony or misdemeanor Conviction.
9	4. Have never had a controlled substance license, permit, or
10	registration suspended or revoked by a State or by the United States Drug
11	Enforcement Administration.
12	5. Have a unique identifier as determined by Commission Rule.
13	6. Hold a Qualifying License.
14	7. Have had no revocation of a License or limitation or
15	restriction on any License currently held due to an adverse action.
16	8. If a Licensee has had a limitation or restriction on a
17	License or Compact Privilege due to an Adverse Action, two years must have
18	elapsed from the date on which the License or Compact Privilege is no longer
19	limited or restricted due to the Adverse Action.
20	9. If a Compact Privilege has been revoked or is limited or
21	restricted in a Participating State for conduct that would not be a basis for
22	disciplinary action in a Participating State in which the Licensee is
23	practicing or applying to practice under a Compact Privilege, that
24	Participating State shall have the discretion not to consider such action as
25	an Adverse Action requiring the denial or removal of a Compact Privilege in
26	that State.
27	10. Notify the Compact Commission that the Licensee is seeking
28	the Compact Privilege in a Remote State.
29	11. Meet any Jurisprudence Requirement of a Remote State in
30	which the Licensee is seeking to practice under the Compact Privilege and pay
31	any fees applicable to satisfying the Jurisprudence Requirement.
32	12. Report to the Commission any Adverse Action taken by a non-
33	participating State within thirty (30) days after the action is taken.
34	B. The Compact Privilege is valid until the expiration or revocation
35	of the Qualifying License unless terminated pursuant to an Adverse Action.
36	The Licensee must also comply with all of the requirements of Subsection A

- 1 above to maintain the Compact Privilege in a Remote State. If the
- 2 Participating State takes Adverse Action against a Qualifying License, the
- 3 <u>Licensee shall lose the Compact Privilege in any Remote State in which the</u>
- 4 Licensee has a Compact Privilege until all of the following occur:
- 5 l. The License is no longer limited or restricted; and
- 6 2. Two (2) years have elapsed from the date on which the License
- 7 is no longer limited or restricted due to the Adverse Action.
- 8 C. Once a restricted or limited License satisfies the requirements of
- 9 Subsection B.1 and 2, the Licensee must meet the requirements of Subsection \underline{A}
- 10 <u>to obtain a Compact Privilege in any Remote State.</u>
- D. For each Remote State in which a PA seeks authority to prescribe
- 12 <u>controlled substances</u>, the PA shall satisfy all requirements imposed by such
- 13 State in granting or renewing such authority.

- 15 <u>Section 5. Designation of the State from Which Licensee is Applying for a</u>
- 16 <u>Compact Privilege</u>
- 17 <u>A. Upon a Licensee's application for a Compact Privilege, the Licensee</u>
- 18 shall identify to the Commission the Participating State from which the
- 19 Licensee is applying, in accordance with applicable Rules adopted by the
- 20 Commission, and subject to the following requirements:
- 21 l. When applying for a Compact Privilege, the Licensee shall
- 22 provide the Commission with the address of the Licensee's primary residence
- 23 and thereafter shall immediately report to the Commission any change in the
- 24 <u>address of the Licensee's primary residence.</u>
- 25 <u>2. When applying for a Compact Privilege, the Licensee is</u>
- 26 required to consent to accept service of process by mail at the Licensee's
- 27 primary residence on file with the Commission with respect to any action
- 28 brought against the Licensee by the Commission or a Participating State,
- 29 <u>including a subpoena, with respect to any action brought or investigation</u>
- 30 <u>conducted by the Commission or a Participating State.</u>

- 32 Section 6. Adverse Actions
- 33 A. A Participating State in which a Licensee is licensed shall have
- 34 exclusive power to impose Adverse Action against the Qualifying License
- 35 <u>issued by that Participating State.</u>
- 36 <u>B. In addition to the other powers conferred by State law, a Remote</u>

- 1 State shall have the authority, in accordance with existing State due process
- 2 law, to do all of the following:
- 3 <u>1. Take Adverse Action against a PA's Compact Privilege within</u>
- 4 that State to remove a Licensee's Compact Privilege or take other action
- 5 necessary under applicable law to protect the health and safety of its
- 6 citizens.
- 7 2. Issue subpoenas for both hearings and investigations that
- 8 require the attendance and testimony of witnesses as well as the production
- 9 of evidence. Subpoenas issued by a Licensing Board in a Participating State
- 10 for the attendance and testimony of witnesses or the production of evidence
- 11 from another Participating State shall be enforced in the latter State by any
- 12 court of competent jurisdiction, according to the practice and procedure of
- 13 that court applicable to subpoenas issued in proceedings pending before it.
- 14 The issuing authority shall pay any witness fees, travel expenses, mileage
- 15 and other fees required by the service statutes of the State in which the
- 16 witnesses or evidence are located.
- 17 3. Notwithstanding paragraph 2, subpoenas may not be issued by a
- 18 Participating State to gather evidence of conduct in another State that is
- 19 lawful in that other State for the purpose of taking Adverse Action against a
- 20 <u>Licensee's Compact Privilege or application for a Compact Privilege in that</u>
- 21 Participating State.
- 22 4. Nothing in this Compact authorizes a Participating State to
- 23 impose discipline against a PA's Compact Privilege or to deny an application
- 24 for a Compact Privilege in that Participating State for the individual's
- 25 <u>otherwise lawful practice in another State.</u>
- 26 <u>C. For purposes of taking Adverse Action, the Participating State</u>
- 27 which issued the Qualifying License shall give the same priority and effect
- 28 to reported conduct received from any other Participating State as it would
- 29 <u>if the conduct had occurred within the Participating State which issued the</u>
- 30 Qualifying License. In so doing, that Participating State shall apply its own
- 31 State laws to determine appropriate action.
- 32 D. A Participating State, if otherwise permitted by State law, may
- 33 <u>recover from the affected PA the costs of investigations and disposition of</u>
- 34 cases resulting from any Adverse Action taken against that PA.
- 35 E. A Participating State may take Adverse Action based on the factual
- 36 <u>findings of a Remote State, provided that the Participating State follows its</u>

1	own procedures for taking the Adverse Action.
2	F. Joint Investigations
3	1. In addition to the authority granted to a Participating State
4	by its respective State PA laws and regulations or other applicable State
5	law, any Participating State may participate with other Participating States
6	in joint investigations of Licensees.
7	2. Participating States shall share any investigative,
8	litigation, or compliance materials in furtherance of any joint or individual
9	investigation initiated under this Compact.
10	G. If an Adverse Action is taken against a PA's Qualifying License,
11	the PA's Compact Privilege in all Remote States shall be deactivated until
12	two (2) years have elapsed after all restrictions have been removed from the
13	State License. All disciplinary orders by the Participating State which
14	issued the Qualifying License that impose Adverse Action against a PA's
15	License shall include a Statement that the PA's Compact Privilege is
16	deactivated in all Participating States during the pendency of the order.
17	H. If any Participating State takes Adverse Action, it promptly shall
18	notify the administrator of the Data System.
19	
20	Section 7. Establishment of the PA Licensure Compact Commission
21	A. The Participating States hereby create and establish a joint
22	government agency and national administrative body known as the PA Licensure
23	Compact Commission. The Commission is an instrumentality of the Compact
24	States acting jointly and not an instrumentality of any one State. The
25	Commission shall come into existence on or after the effective date of the
26	Compact as set forth in Section 11.A.
27	B. Membership, Voting, and Meetings
28	1. Each Participating State shall have and be limited to one (1)
29	delegate selected by that Participating State's Licensing Board or, if the
30	State has more than one Licensing Board, selected collectively by the
31	Participating State's Licensing Boards.
32	2. The delegate shall be either:
33	a. A current PA, physician or public member of a Licensing
34	Board or PA Council/Committee; or
35	b. An administrator of a Licensing Board.
36	3. Any delegate may be removed or suspended from office as

1	provided by the laws of the State from which the delegate is appointed.
2	4. The Participating State Licensing Board shall fill any
3	vacancy occurring in the Commission within sixty (60) days.
4	5. Each delegate shall be entitled to one (1) vote on all
5	matters voted on by the Commission and shall otherwise have an opportunity to
6	participate in the business and affairs of the Commission. A delegate shall
7	vote in person or by such other means as provided in the bylaws. The bylaws
8	may provide for delegates' participation in meetings by telecommunications,
9	video conference, or other means of communication.
10	6. The Commission shall meet at least once during each calendar
11	year. Additional meetings shall be held as set forth in this Compact and the
12	<u>bylaws.</u>
13	7. The Commission shall establish by Rule a term of office for
14	delegates.
15	C. The Commission shall have the following powers and duties:
16	1. Establish a code of ethics for the Commission;
17	2. Establish the fiscal year of the Commission;
18	3. Establish fees;
19	4. Establish bylaws;
20	5. Maintain its financial records in accordance with the bylaws;
21	6. Meet and take such actions as are consistent with the
22	provisions of this Compact and the bylaws;
23	7. Promulgate Rules to facilitate and coordinate implementation
24	$\underline{\text{and administration of this Compact.}}$ The Rules shall have the force and $\underline{\text{effect}}$
25	of law and shall be binding in all Participating States;
26	8. Bring and prosecute legal proceedings or actions in the name
27	$\underline{\text{of the Commission, provided that the standing of any State Licensing Board to}$
28	sue or be sued under applicable law shall not be affected;
29	9. Purchase and maintain insurance and bonds;
30	10. Borrow, accept, or contract for services of personnel,
31	including, but not limited to, employees of a Participating State;
32	11. Hire employees and engage contractors, elect or appoint
33	$\underline{\text{officers, fix compensation, define duties, grant such individuals appropriate}}$
34	authority to carry out the purposes of this Compact, and establish the
35	Commission's personnel policies and programs relating to conflicts of
36	interest, qualifications of personnel, and other related personnel matters;

1	12. Accept any and all appropriate donations and grants of
2	money, equipment, supplies, materials and services, and receive, utilize and
3	dispose of the same; provided that at all times the Commission shall avoid
4	any appearance of impropriety or conflict of interest;
5	13. Lease, purchase, accept appropriate gifts or donations of,
6	or otherwise own, hold, improve or use, any property, real, personal or
7	mixed; provided that at all times the Commission shall avoid any appearance
8	of impropriety;
9	14. Sell, convey, mortgage, pledge, lease, exchange, abandon, or
10	otherwise dispose of any property real, personal, or mixed;
11	15. Establish a budget and make expenditures;
12	16. Borrow money;
13	17. Appoint committees, including standing committees composed
14	of members, State regulators, State legislators or their representatives, and
15	consumer representatives, and such other interested persons as may be
16	designated in this Compact and the bylaws;
17	18. Provide and receive information from, and cooperate with,
18	law enforcement agencies;
19	19. Elect a Chair, Vice Chair, Secretary and Treasurer and such
20	other officers of the Commission as provided in the Commission's bylaws.
21	20. Reserve for itself, in addition to those reserved
22	exclusively to the Commission under the Compact, powers that the Executive
23	Committee may not exercise;
24	21. Approve or disapprove a State's participation in the Compact
25	based upon its determination as to whether the State's Compact legislation
26	departs in a material manner from the Model Compact language;
27	22. Prepare and provide to the Participating States an annual
28	report; and
29	23. Perform such other functions as may be necessary or
30	appropriate to achieve the purposes of this Compact consistent with the State
31	regulation of PA licensure and practice.
32	D. Meetings of the Commission
33	1. All meetings of the Commission that are not closed pursuant
34	to this subsection shall be open to the public. Notice of public meetings
35	shall be posted on the Commission's website at least thirty (30) days prior
36	to the public meeting.

1	2. Notwithstanding subsection D.1 of this section, the
2	Commission may convene a public meeting by providing at least twenty-four
3	(24) hours prior notice on the Commission's website, and any other means as
4	provided in the Commission's Rules, for any of the reasons it may dispense
5	with notice of proposed rulemaking under Section 9.L.
6	3. The Commission may convene in a closed, non-public meeting or
7	non-public part of a public meeting to receive legal advice or to discuss:
8	a. Non-compliance of a Participating State with its
9	obligations under this Compact;
10	b. The employment, compensation, discipline or other
11	matters, practices or procedures related to specific employees or other
12	matters related to the Commission's internal personnel practices and
13	procedures;
14	c. Current, threatened, or reasonably anticipated
15	litigation;
16	d. Negotiation of contracts for the purchase, lease, or
17	sale of goods, services, or real estate;
18	e. Accusing any person of a crime or formally censuring
19	any person;
20	f. Disclosure of trade secrets or commercial or financial
21	information that is privileged or confidential;
22	g. Disclosure of information of a personal nature where
23	disclosure would constitute a clearly unwarranted invasion of personal
24	privacy;
25	h. Disclosure of investigative records compiled for law
26	enforcement purposes;
27	i. Disclosure of information related to any investigative
28	reports prepared by or on behalf of or for use of the Commission or other
29	committee charged with responsibility of investigation or determination of
30	compliance issues pursuant to this Compact;
31	j. Legal advice; or
32	k. Matters specifically exempted from disclosure by
33	federal or Participating States' statutes.
34	4. If a meeting, or portion of a meeting, is closed pursuant to
35	this provision, the chair of the meeting or the chair's designee shall
36	certify that the meeting or portion of the meeting may be closed and shall

- 1 reference each relevant exempting provision.
- 2 <u>5. The Commission shall keep minutes that fully and clearly</u>
- 3 describe all matters discussed in a meeting and shall provide a full and
- 4 accurate summary of actions taken, including a description of the views
- 5 expressed. All documents considered in connection with an action shall be
- 6 identified in such minutes. All minutes and documents of a closed meeting
- 7 shall remain under seal, subject to release by a majority vote of the
- 8 Commission or order of a court of competent jurisdiction.
 - E. Financing of the Commission
- 10 <u>1. The Commission shall pay, or provide for the payment of, the</u>
- ll reasonable expenses of its establishment, organization, and ongoing
- 12 <u>activities</u>.

- 13 <u>2. The Commission may accept any and all appropriate revenue</u>
- 14 sources, donations, and grants of money, equipment, supplies, materials, and
- 15 <u>services</u>.
- 16 3. The Commission may levy on and collect an annual assessment
- 17 from each Participating State and may impose Compact Privilege fees on
- 18 <u>Licensees of Participating States to whom a Compact Privilege is granted to</u>
- 19 cover the cost of the operations and activities of the Commission and its
- 20 staff, which must be in a total amount sufficient to cover its annual budget
- 21 as approved by the Commission each year for which revenue is not provided by
- 22 other sources. The aggregate annual assessment amount levied on Participating
- 23 States shall be allocated based upon a formula to be determined by Commission
- 24 Rule.
- 25 <u>a. A Compact Privilege expires when the Licensee's</u>
- 26 Qualifying License in the Participating State from which the Licensee applied
- 27 <u>for the Compact Privilege expires.</u>
- 28 b. If the Licensee terminates the Qualifying License
- 29 through which the Licensee applied for the Compact Privilege before its
- 30 <u>scheduled expiration</u>, and the <u>Licensee has a Qualifying License in another</u>
- 31 Participating State, the Licensee shall inform the Commission that it is
- 32 <u>changing to that Participating State the Participating State through which it</u>
- 33 applies for a Compact Privilege and pay to the Commission any Compact
- 34 Privilege fee required by Commission Rule.
- 35 <u>4. The Commission shall not incur obligations of any kind prior</u>
- 36 to securing the funds adequate to meet the same; nor shall the Commission

1	pledge the credit of any of the Participating States, except by and with the
2	authority of the Participating State.
3	5. The Commission shall keep accurate accounts of all receipts
4	$\underline{\text{and disbursements.}}$ The receipts and disbursements of the Commission shall be
5	subject to the financial review and accounting procedures established under
6	its bylaws. All receipts and disbursements of funds handled by the Commission
7	shall be subject to an annual financial review by a certified or licensed
8	public accountant, and the report of the financial review shall be included
9	in and become part of the annual report of the Commission.
10	F. The Executive Committee
11	1. The Executive Committee shall have the power to act on behalf
12	of the Commission according to the terms of this Compact and Commission
13	Rules.
14	2. The Executive Committee shall be composed of nine (9)
15	members:
16	a. Seven voting members who are elected by the Commission
17	from the current membership of the Commission;
18	b. One ex-officio, nonvoting member from a recognized
19	national PA professional association; and
20	c. One ex-officio, nonvoting member from a recognized
21	national PA certification organization.
22	3. The ex-officio members will be selected by their respective
23	organizations.
24	4. The Commission may remove any member of the Executive
25	Committee as provided in its bylaws.
26	5. The Executive Committee shall meet at least annually.
27	6. The Executive Committee shall have the following duties and
28	responsibilities:
