| 20 | BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS: |

| 22 | SECTION 1. Arkansas Code Title 14, Chapter 356, Subchapter 1, is |
| 23 | amended to add an additional section to read as follows: |
| 24 | 14-356-103. Expedited security screening - Definitions. |
| 25 | (a) As used in this section: |
| 26 | (1) "Airline" means an organization providing a regular public |
| 27 | service of commercial air transportation on one (1) or more routes; |
| 28 | (2) "Expedited security screening" means a service provided by a |
| 29 | vendor at a public airport that allows a person to use a standard security |
| 30 | lane or a United States Transportation Security Administration PreCheck |
| 31 | Program lane for the purpose of a security screening instead of the standard |
| 32 | security screening provided at the public airport; |
| 33 | (3)(A) "Public airport" means a tract of land or water owned by |
| 34 | a governmental entity with buildings and facilities for the landing, takeoff, |
| 35 | shelter, supply, and repair of aircraft. |
| 36 | (B) "Public airport" includes without limitation: |

| 6 | (4) "Public airport operator" means a person or entity that is |
| 7 | authorized to manage or run a public airport, including without limitation an |
| 8 | airport authority, fixed-base operator, or other agency; and |
| 9 | (5) "Vendor" means a private third-party vendor that provides an |
| 10 | expedited security screening. |
| 11 | (b) A public airport operator may enter into an agreement with a |
| 12 | vendor to provide an expedited security screening only if the vendor has |
| 13 | obtained a dedicated Transportation Security Administration security lane at |
| 14 | the public airport operated by the public airport operator exclusively to |
| 15 | provide an expedited security screening. |
| 16 | (c)(l) A public airport operator may enter into an agreement with an |
| 17 | airline to provide an expedited security screening offered by an airline for |
| 18 | exclusive use by passengers of the airline. |
| 19 | (2) An agreement between a public airport operator and an |
| 20 | airline to provide an expedited security screening for the exclusive use of |
| 21 | passengers of the airline shall not require a passenger using the expedited |
| 22 | security screening to pay an additional fee to a vendor. |

| 24 | Section 2. DO NOT CODIFY. <u>Retroactivity.</u> |
| 25 | This act applies retroactively to all agreements entered into by a |
| 26 | public airport operator on or after January 1, 2025. |
