3	REQUESTING THE HOUSE COMMITTEE ON AGING, CHILDREN AND YOUTH, AND
4	LEGISLATIVE AFFAIRS STUDY THE REVISION OF EXISTING PROCEDURES
5	GOVERNING THE CHILD ABUSE HOTLINE AND SUBSEQUENT INVESTIGATIONS
6	OF ALLEGED CHILD MALTREATMENT; AND THE CREATION OF A MORE
7	STANDARDIZED PROCEDURE FOR THE ACCEPTANCE OR NON-ACCEPTANCE OF A
8	REPORT OF ALLEGED CHILD MALTREATMENT TO THE CHILD ABUSE HOTLINE,
9	MANDATORY REPORTING OF SUSPECTED CHILD MALTREATMENT TO THE CHILD
10	ABUSE HOTLINE, AND SUBSEQUENT INVESTIGATIONS OF ALLEGED CHILD
11	MALTREATMENT.

13	WHEREAS, the Child Abuse Hotline, created in the Arkansas Code under §
14	12-18-301 and operated under the Child Maltreatment Act, § $12-18-101$ et seq.,
15	by the Department of Human Services and the Division of Arkansas State
16	Police, or their designee, serves the purpose of receiving and recording
17	reports of alleged child maltreatment in the state; and
18	
19	WHEREAS, the Child Abuse Hotline is critical infrastructure in the
20	child welfare system of this state, of which the reporting to may lead to the
21	provision of services to assist a family, the opening of a dependency-neglect
22	case necessary to protect the health and safety of a child, and the potential
23	filing of criminal charges against an individual for alleged child
24	maltreatment that constitutes a crime under the laws of this state; and
25	
26	WHEREAS, many of the procedures governing the operation of the Child
27	Abuse Hotline, including without limitation procedures for accepting or not
28	accepting a report of alleged child maltreatment, are outlined in rules
29	promulgated by the Department of Human Services under the Administrative
30	Procedure Act, § 25-15-201 et seq., and are not codified in state statute;

33	WHEREAS, there are several states in the country that have highly
34	standardized procedures for accepting or not accepting a report to their
35	respective child maltreatment reporting systems, many of which are outlined

in state statute; and

WHEREAS, existing procedures regarding mandatory reporting of suspected child maltreatment should also be evaluated for clarity, efficiency, and comprehensive protection of vulnerable children in the state; and

WHEREAS, there are documented concerns both within and outside of recent meetings of this legislative body that reporting and subsequent investigations of alleged child maltreatment in this state are a cause for confusion due to inconsistent interpretation and application of existing procedures, which poses concern and danger to children and families in this state; and

WHEREAS, some of this concern lies within inconsistent interpretation and application of child maltreatment procedures within state entities and with partners of state entities, including without limitation children's advocacy centers, emergency rooms, hospitals and practitioners such as the Team for Children at Risk at the Arkansas Children's Hospital; and

WHEREAS, specific causes for concern of the committee regarding investigations of alleged child maltreatment include physical and mental examinations of children who are the alleged victims of child maltreatment, photography and videography of children who are the alleged victims of child maltreatment, and explanation of parental rights and the consent of a parent or legal guardian of a child to such examinations, photography, and videography; and

WHEREAS, procedures that provide for more consistent acceptance or non-acceptance of reports to the Child Abuse Hotline, updates to procedures regarding mandatory reporting of suspected child maltreatment to the Child Abuse Hotline, and subsequent investigations of alleged child maltreatment, including without limitation examinations, photography, and videography of a child and explanations of parental rights and consent, are likely to promote efficiency and accountability in the state's child welfare system, as well as greater protection of vulnerable children in this state,

NOW THEREFORE,

1	BE IT PROPOSED BY THE House Committee on Aging, Children and Youth, and
2	Legislative Affairs OF THE NINETY-FIFTH GENERAL ASSEMBLY:
3	
4	THAT the House Committee on Aging, Children and Youth, and Legislative
5	Affairs study the revision of existing procedures governing the Child Abuse
6	Hotline and the creation of more standardized and effective procedures for
7	the acceptance or non-acceptance of a report of alleged child maltreatment to
8	the Child Abuse Hotline, mandatory reporting of suspected child maltreatment
9	to the Child Abuse Hotline, and subsequent investigations of alleged child
10	maltreatment.
