The Arkansas Legislative Council referred a rule from The Arkansas State Board of Pharmacy, regarding drug substitution and limits of dispensing for Schedule II narcotics, to the Senate and House Committees on Public Health, Welfare and Labor for a recommendation.

The House and Senate Interim Committees on Public Health, Welfare & Labor held a hearing on December 4, 2017, to consider a recommendation on this rule proposed by the Arkansas State Board of Pharmacy.
