

### COMPARISON OF THE FIRST MONTH OF THE 2022-2023 FISCAL YEAR DISTRIBUTION OF GROSS GENERAL REVENUES WITH THE SAME PERIOD OF THE 2021-2022 FISCAL YEAR State Fiscal Year is July 1, 2021 through June 30, 2022

Collections of Gross General Revenues year-to-date of approximately \$615.9 million have increased \$15.5 million, or 2.6% above the \$600 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$541.9 million increased \$27.1 million, or 5.3% from the \$514.9 million available for distribution in July 2021.
