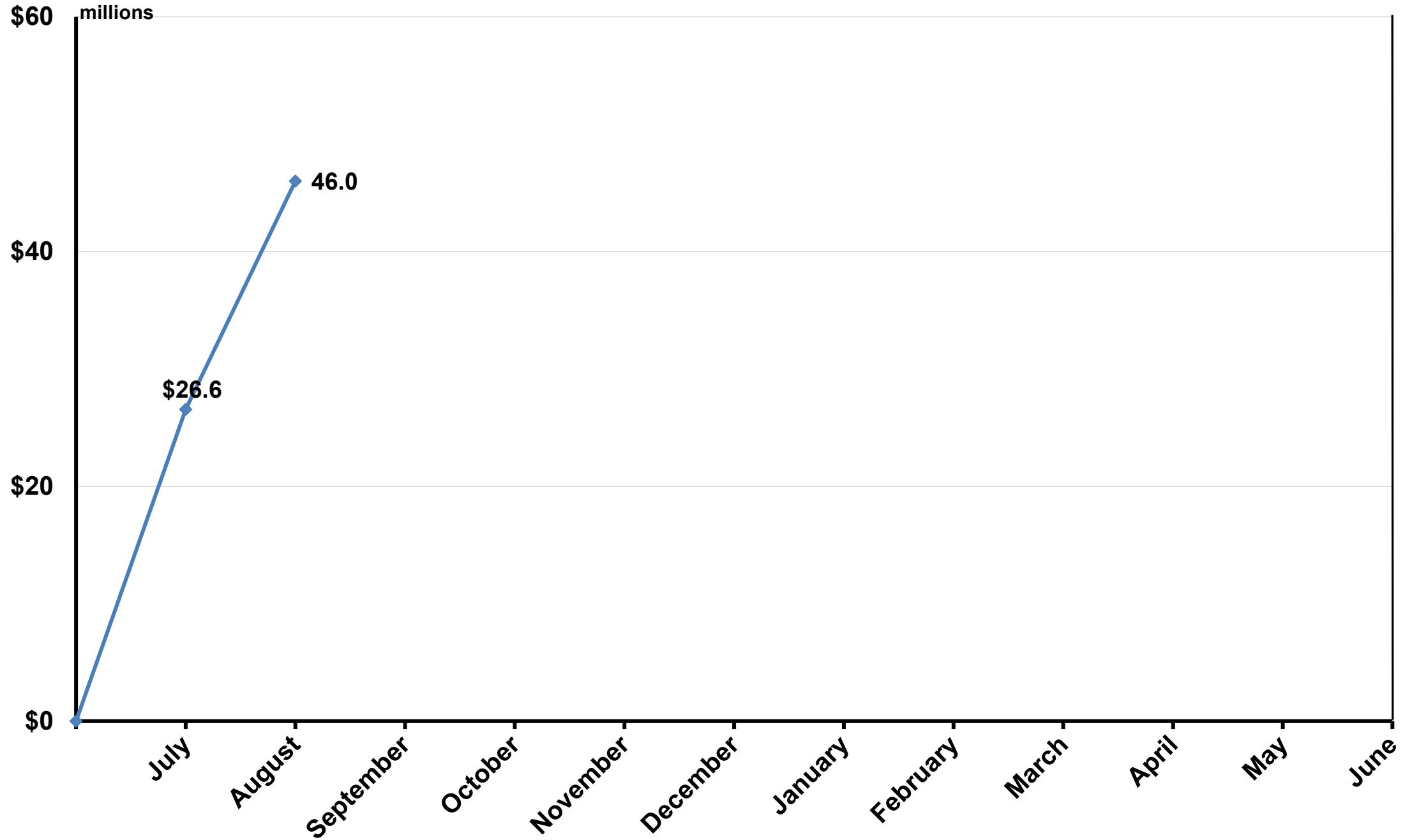
COMPARISON OF THE FIRST TWO MONTHS OF THE 2022-2023 FISCAL YEAR

State Fiscal Year is July 1, 2022 through June 30, 2023

Collections of Gross General Revenues year-to-date of approximately \$1,230.6 million have increased \$41.7 million, or 3.5% above the \$1,188.9 million collected last fiscal year-to-date. Net General Revenue Available for distribution of \$1,084.0 million increased \$50.2 million, or 4.9% from the \$1,033.8 million available for distribution in August 2021.
