RE: Joint Performance Review Committee Reporting Requirements for Act 276 of 2021

Senator Rice and Representative Wardlaw:

According to Arkansas Code Annotated § 25-1-106, as amended by Act 276 of 2021, no later than August 1 of each even-numbered year, each state board and commission shall provide the Joint Performance Review Committee with a report of the regularly scheduled meeting dates for the state board or commission for the previous two (2) fiscal years, including the attendance record of each member and the number of meetings that were convened.

The Joint Performance Review Committee is required to report its findings and any recommendations concerning the constitutional board or commission to the Legislative Council no later than December 1 of each even-numbered year and may draft legislation to implement the recommendations.

Findings

Arkansas Code Annotated § 25-1-106 does not include a definitive list identifying the boards and commissions that are required to comply with this Act. Specifically, when it comes to defining Amendment 33 entities.

According to the "Aggregated List of State, Federal, and Other Entities Mentioned in the Arkansas Code of 1987 Annotated – Updated September 2021," the following is noted:

- 1. There are approximately 231 boards and commissions.
- 2. There are approximately 56 Potential Arkansas Constitution Amendment 33 Entities.

Approximately 89 boards and commissions have complied with the requirements of Arkansas Code Annotated § 25-1-106. It is evident by the responses received, that many boards and commission were unaware of Act 276 of 2021, and the additional reporting requirements. Attached is a list of boards and commissions who have complied as well as those who have not complied. [Attachments A and B]

Recommendations:

- 1. Based on the numbers of respondents, many boards and commissions are unaware of the additional reporting requirements of Act 276 of 2021.
 - a. Identify a definitive list of the boards and commissions required to comply.
 - b. Develop a method to make boards and commissions aware of the requirements.
 - c. The Joint Performance Review Committee is not recommending any draft legislation under Arkansas Code Annotated § 25-1-106 with regard to any state board or commission or constitutional board or commission (as that is a specific action that is set out in the statute).

- (b)(1)(c)(1) If a part-time state board or commission has not convened a regularly scheduled meeting or has convened without a quorum for four (4) consecutive, regularly scheduled meeting dates within a the preceding two-year period, the Joint Performance Review Committee shall reevaluate the purpose, need, and effectiveness of the state board or commission.
- (2) The Joint Performance Review Committee shall report its findings and any recommendations concerning the existence of the <u>state</u> board or commission to the Legislative Council no later than December 1 of each even-numbered year and shall draft legislation to implement the recommendations.

(e)(d)(1) No later than August 1 of each even-numbered year, each part-time state board and commission shall provide the Joint Performance Review Committee with a list report of the regularly scheduled meeting dates for the state board or commission for the previous two (2) fiscal years, including the attendance record of each member and the number of meetings that were convened.

- (2) If a state board or commission, other than a constitutional board or commission, has not submitted the report required in subdivision (d)(1) of this section to the Joint Performance Review

 Committee by August 1 of each even-numbered year, the authority of the state board or commission may be suspended on August 1 of the even-numbered year by the Joint Performance Review Committee at the next Joint Performance Review Committee meeting, and the state board or commission may not take any action, including the expenditure of funds, until the report required in subdivision (d)(1) of this section is provided to the Joint Performance Review Committee.
- (3) <u>If a state board or commission, other than a constitutional board or commission, has not submitted the report required in subdivision</u>

(d)(1) of this section to the Joint Performance Review Committee by *December* 1 of the even-numbered year, the Joint Performance Review Committee may direct the Bureau of Legislative Research to draft legislation that:

- (A) <u>Abolishes the state board or commission upon sine die</u> <u>adjournment of the next regular</u> session of the General Assembly;
- (B) Allows the reversion of all authority of the state board or commission to the General

 Assembly or to the General Assembly's designee; and
- (C) Requires all funds, income, and revenue to revert to the General Revenue Fund Account or other fund or account as provided by the General Assembly.
 - (4) This section does not prohibit the General Assembly from:
 - (A) Abolishing a state board or commission, other than a constitutional board or commission, that has submitted a report; or

(B) Considering any other legislation relative to a state agency subject to this chapter.

(5) Except as otherwise provided, abolition of a state board or commission does not affect rights and duties that mature, penalties that were incurred, civil or criminal liabilities that arose, or proceedings that were begun before the effective date of the abolition of the board or commission.

(e)(1) If a constitutional board or commission has not convened a regularly scheduled meeting or has convened without a quorum for four (4) consecutive, regularly scheduled meeting dates within the preceding two-year period, the Joint Performance Review Committee shall reevaluate the purpose, need, and effectiveness of the constitutional state board or commission.

(2) The Joint Performance Review Committee shall report its findings and any recommendations concerning the constitutional board or commission to the Legislative Council no later than December 1 of each even numbered year and may draft legislation to implement the recommendations.
