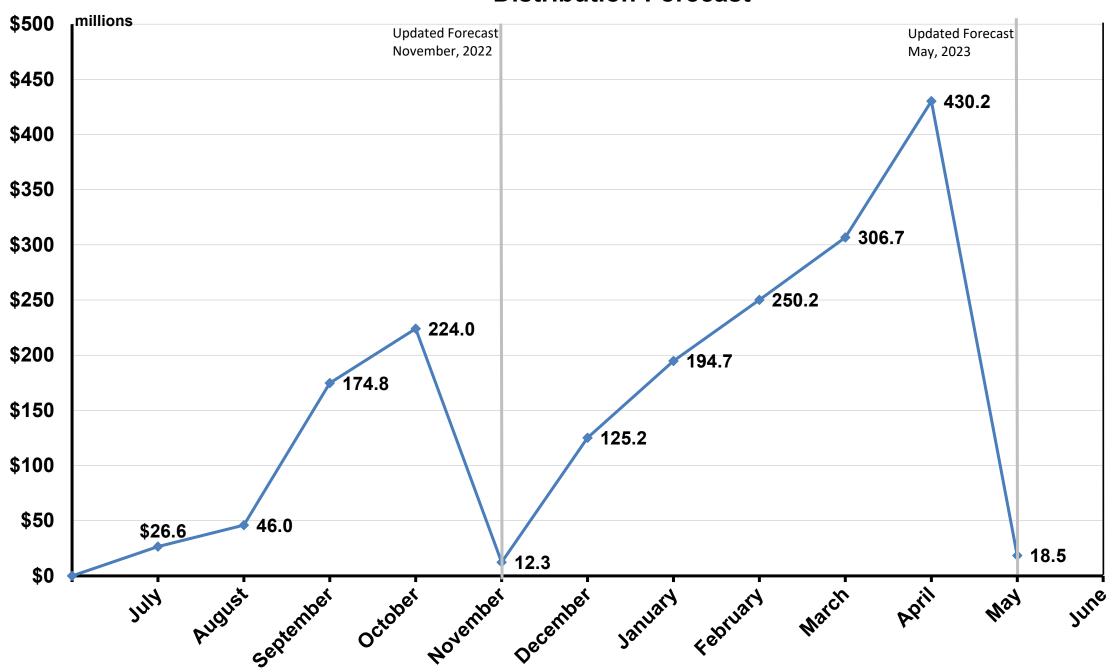
## COMPARISON OF THE FIRST ELEVEN MONTHS OF THE 2022-2023 FISCAL YEAR DISTRIBUTION OF GROSS GENERAL REVENUES WITH THE SAME PERIOD OF THE 2021-2022 FISCAL YEAR

State Fiscal Year is July 1, 2022 through June 30, 2023

Collections of General Revenues year-to-date of approximately \$7,898.9 million have increased \$28.9 million, or 0.4% above the \$7,869.96 million collected last fiscal year-to-date. Net General Revenue Available for distribution of \$6,415.5 million decreased \$282.9 million, or 4.2% from the \$6,698.4 million available for distribution in May 2022.
