Senator Rice and Representative Wardlaw:

The Lottery Oversight Subcommittee met Monday, December 11, 2023, at 2:30 pm, in Committee Room B-MAC, Little Rock, Arkansas.

The Subcommittee heard testimony regarding the following items:

1. An update of the Office of the Arkansas Lottery Activities and Operations; and
2. Recommendations for the Arkansas Academic Challenge Scholarship Program, with testimony from Mr. Nick Fuller, Deputy Director, Arkansas Division of Higher Education.

Senator Jimmy Hickey, Jr. made a motion to amend the Lottery Oversight Subcommittee's annual report to the Arkansas Legislative Council, to remove Camelot Global Services as a term contract. The motion was seconded by Representative Carol Dalby and carried by voice-vote.
