### COMPARISON OF THE FIRST SIX MONTHS OF THE 2023-2024 FISCAL YEAR DISTRIBUTION OF GROSS GENERAL REVENUES WITH THE SAME PERIOD OF THE 2022-2023 FISCAL YEAR State Fiscal Year is July 1, 2023 through June 30, 2024

Collections of Gross General Revenues year-to-date of approximately \$4,092.97 million have decreased \$52.3 million, or 1.3% below the \$4,145.24 million collected last fiscal year-to-date. Net General Revenue Available for distribution of \$3,429.3 million decreased \$182.1 million, or 5.0% from the \$3,611.41 million available for distribution in December 2022.
