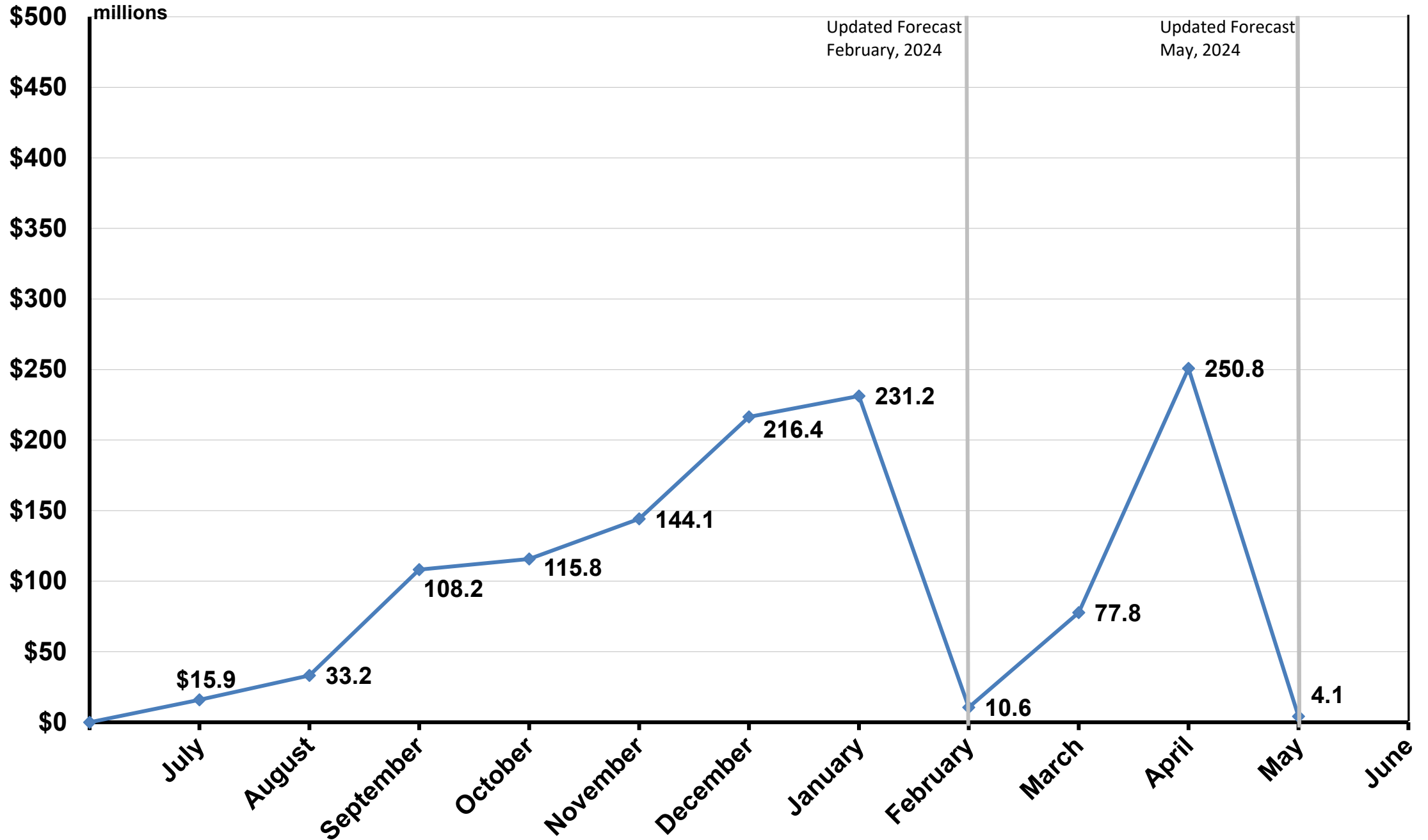
COMPARISON OF THE FIRST ELEVEN MONTHS OF THE 2023-2024 FISCAL

State Fiscal Year is July 1, 2023 through June 30, 2024

Collections of Gross General Revenues year-to-date of approximately \$7,810.54 million have decreased \$88.3 million, or 1.1% below the \$7,898.86 million collected last fiscal year-to-date. Net General Revenue Available for distribution of \$6,149.5 million decreased \$265.9 million, or 4.1% from the \$6,415.46 million available for distribution in April 2023.
