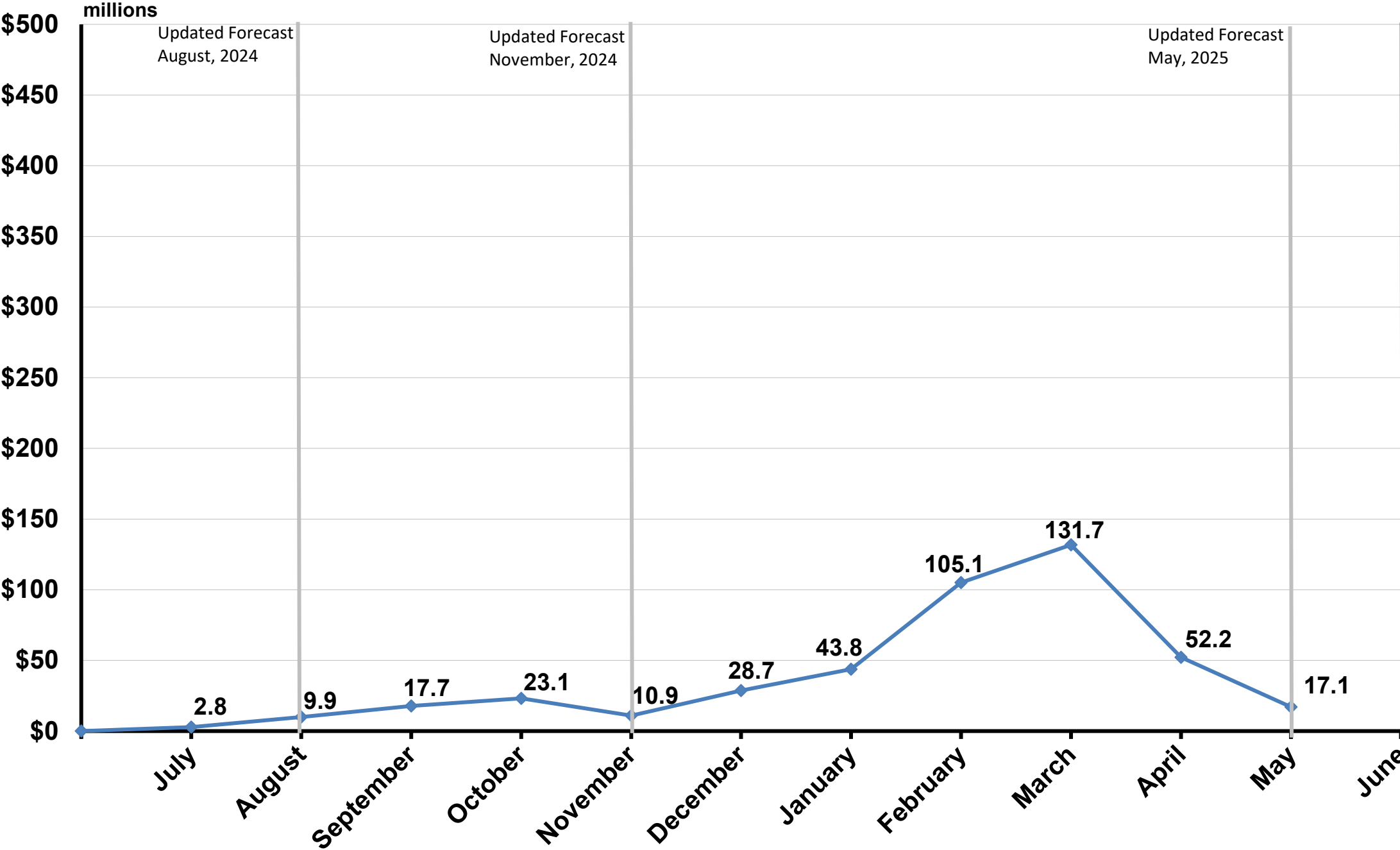
COMPARISON OF THE FIRST ELEVEN MONTHS OF THE 2024-2025 FISCAL YEAR

State Fiscal Year is July 1, 2024 through June 30, 2025

Collections of Gross General Revenues year-to-date of approximately \$7,437.84 million have decreased \$372.7 million, or 4.8% below the \$7,810.54 million collected last fiscal year-to-date. Net General Revenue Available for distribution of \$5,904.9 million decreased \$244.6 million, or 4.0% from the \$6,149.53 million available for distribution in May 2024.
