The plan amendment provides flexibility to rural hospitals which have not yet met the metrics in their existing sustainability plan to now have an expanded list of defined operational metrics to choose from that better align with their unique circumstances.

Any new metrics selected by hospitals, new tracks, and extended performance timelines will be incorporated into revised sustainability plans and grant agreements. If a hospital achieves the metrics and deliverables of the revised plan and reviews are satisfactorily completed, payment will be made accordingly without further legislative review, up to the amounts already appropriated by ALC.

As noted in the Alvarez and Marsal report dated June 2023, the State of Arkansas has a number of rural hospitals which may have been impacted significantly by the COVID-19 pandemic, increases in the cost of care, and/or reduced revenue. The State retained Alvarez and Marsal to conduct an independent review of the near- and medium-term financial condition and operating performance of Arkansas' rural hospitals to help inform the State's distribution of SFRF support.

Based on the work of Alvarez and Marsal, Department of Finance and Administration (DFA) and Department of Human Services (DHS) worked in collaboration to develop a grant assistance program for qualifying rural hospitals. Payment of the assistance occurred in up to three tranches based on the attainment of operational and financial metrics agreed up by DFA/DHS and the hospitals. The grant awards were approved by ALC in FY 2024.

Based upon feedback from both the hospitals and the consultants, there is interest in amending the program to recognize improvement by hospitals that the self-selected metrics may not adequately reflect. The amendment would allow for the hospitals select a new set of metrics, providing flexibility to the hospitals thus allowing for the next round of payments. These options will not change the amount of funding awarded to the hospitals.

Option 1: Extend the 12-month evaluation period by *six months*, allowing hospitals to meet either the 6-month or 12-month metrics targets *at any time* in the eighteen-month period with a three-month, sixmonth or twelve-month trailing average to obtain funding tied to the targets.

Option 2: Correct baseline calculation to allow for an equivalent, side by side comparison of the baseline to current operations and to fully recognize improvements made by hospitals in response to the Rural Hospital Sustainability Program.

Option 3: Change one or both selected metrics to any of the five operating metrics listed in the Sustainability Program. Those metrics include Operating Margin, Days in Accounts Receivable, Net, Days Cash on Hand, FTE / Adjusted Occupied Bed and Labor to Net Patient Service Revenue (NPSR). Calculations for these metrics remain the same.

Option 4: Provide any combination of Option 1, Option 2, and Option 3 to hospitals.

Option 5: Transition from *Track 2* (Strategic Hospital Improvement) to *Track 1* (Transformative Hospital Reform).
