HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$5,038.1 million have increased \$277.6 million, or 5.8%, above the \$4,760.5 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$407.1 million increased \$65 million, or 19%, from the \$342.1 million available for distribution in March 2018. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,207,773.40 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$19,869,960.60.

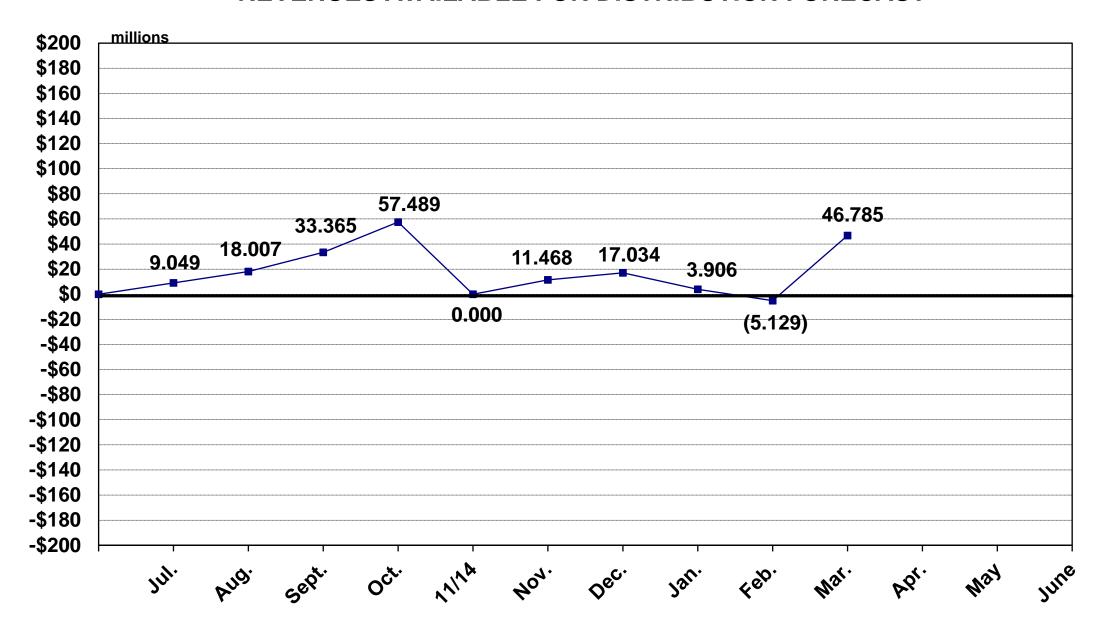
