24	food service establishment designed to be readily movable and approved to		
25	travel highways and waterways that is a self-contained retail food		
26	establishment with permanently mounted freshwater and waste tanks.		
27	(2) "Mobile unit" includes food trucks.		
28	(3) "Mobile unit" does not include cottage food production		
29	operations.		
30	(b) A mobile unit may sell food to another mobile unit or other food		
31	service establishment.
