Collections of Gross General Revenues year-to-date of approximately \$6,495.1 million have increased \$416.5 million, or 6.9%, above the \$6,078.6 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$378.6 million increased \$31.2 million, or 9.0%, from the \$347.4 million available for distribution in May 2018. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,207,773.40 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$24,285,507.40.


